**On the corner of Potunk Lane & Main St.**  
**Westhampton Beach, NY**

- Location:** **Corner of Potunk Lane & Main Street**, Westhampton Beach.  
Directions: Sunrise Hwy. East to Exit 63, South on Rt. 31 (Old Riverhead Rd.) Go through 2 traffic lights- after going across Montauk Hwy you will be on Oak Street. When you come to the traffic circle, go halfway around the circle to continue south on Potunk Lane. Continue straight until you reach the corner of Main Street and Potunk Lane (Main Street will be on your left). Go past field and enter from back parking area.
- Time:** The Flea Market will be open to the public from 10:00 AM until 6:00 PM on Saturday and from 12:00 PM to 5:00 PM on Sunday. You will be able to set up your displays on Saturday from 6:30 AM on, and on Sunday from 8 AM on. **No vehicle will be permitted to move on the grounds after 9:30 AM. We reserve the right to reassign spaces to those that arrive after 9:30 AM.** We are unable to accommodate early sales on Sunday.
- Display Area:** You are responsible for your tables and chairs and other display equipment. The Westhampton Rotary does not provide or rent tables and chairs. Please note, tents greater than 10 x 10 require a permit as per the Village of Westhampton Beach.
- Confirmation:** You will receive confirmation of your reserved space by mail once received. Every effort will be made to assign spaces on a first come first served basis- be sure to indicate the type of goods you are selling so we can arrange our vendors properly.
- Food:** Food and beverages will be available throughout the day.
- Security:** Members of the Westhampton Rotary Club will be on site from 6:30 AM until 7:00PM on Saturday and 8:00 AM till close on Sunday. It is understood and agreed that neither the Westhampton Rotary Club nor any of its officers, directors or members shall be in any way responsible or liable for any loss or damage to merchandise and goods displayed by exhibitors, whether such loss or damage occurs during the hours of public exhibition or at any other time. Each exhibitor shall be solely and exclusively responsible for policing his site and safeguarding his property. Due notice of this provision is given to participants and is made a part of the Space Rental Agreement entered into by each exhibitor. Payment of the requisite fee and or actual participation by any exhibitor shall be deemed acceptance of the terms thereof.
- Facilities:** First aid services and toilet facilities will be available on the grounds each day.
- Limitations:** The Rotary Club of Westhampton reserves the right to cancel this neutral Agreement at any stage, either prior to or during the course of the Show if it deems that the conduct of any vendor or the nature of his merchandise is not in the best interest of the Show. Upon such cancellation, the rental fee shall be returned.
