This reflects one primary member (\$348 includes Rotary International dues, Rotary District dues and Club dues) registered as a Rotarian with Rotary International and two alternates (\$120 participant Club dues) who are club participants. \$17.70 per meal consumed at meetings will be added to the quarterly billing.
