**Acknowledgment and Assumption of Inherent Dangers and Risks**

Signed acknowledgment by both the player and the player’s parent or guardian is required for participation.

I/My child, hereinafter “Participant,” will be participating in a basketball tournament hosted by the Rotary Club of Helena. I acknowledge that basketball involves inherent dangers and risks that cannot be eliminated and that may result in personal injury. I acknowledge that such inherent dangers and risks may include, but are not limited to: death; neck and spinal injuries; brain injuries; eye injuries; injury to internal organs; injury to bones, joints, ligaments, muscles, tendons, and other parts of the body; acts or omissions of other participants or others in the area; and injury resulting from failure to follow instructions of tournament staff. I acknowledge that Participant could suffer injuries while participating, even if Participant, the Rotary Club of Helena, and others act with the utmost care and ability.

I agree that Participant has a duty at all times to follow the instructions of tournament staff, to engage in a manner that avoids injury to Participant and others, and to be aware of inherent dangers and risks of participating. I accept all legal responsibility for injury or damage of any kind that occurs during Participant’s participation, including but not limited to those known inherent dangers and risks identified above.

BY SIGNING THIS DOCUMENT YOU MAY BE WAIVING YOUR LEGAL RIGHT TO A JURY TRIAL TO HOLD THE PROVIDER LEGALLY RESPONSIBLE FOR ANY INJURIES OR DAMAGES RESULTING FROM RISKS INHERENT IN THE SPORT OR RECREATIONAL OPPORTUNITY OR FOR ANY INJURIES OR DAMAGES THAT YOU MAY SUFFER DUE TO THE PROVIDER’S ORDINARY NEGLIGENCE THAT ARE THE RESULT OF THE PROVIDER’S FAILURE TO EXERCISE REASONABLE CARE.
