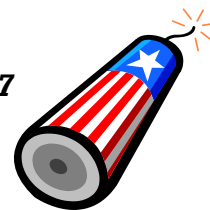

Awards for only the 5-mile race will be given to the first 5 male and female overall finishers and to the first 3 finishers in each of the following age groups: U14, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-79 & 80+. No awards will be given nor times recorded for the 3.1 mile walkers.

Held in conjunction with the Granville Kiwanis Fourth of July Street Fair, July 1 through July 4. Bring your family and enjoy the entertainment, food, games and rides. **The race starts at Granville High School (248 New Burg Street) at 7:45am, rain or shine.** Check-in and post entries between 6:30 and 7:30am at the rear of Granville High School. Dressing and shower facilities are available at Granville High School—provide your own towel and lock. Any runner twelve years of age or younger must be accompanied by an adult on the course.
