GRANT APPLICATION CONSIDERATION AGREEMENT

In consideration of the review of your Grant Application by the Benzie Sunrise Rotary Foundation, Inc. ("the Foundation"), the undersigned hereby agrees to the following terms and conditions. In the event that the Foundation awards such a grant, these terms and conditions will remain in full force and effect until such time as all requirements of the grant have been fully and completely satisfied.

The following conditions are attached to and govern the distribution and use of the grant:

- 1. The grant is to be used solely for the purposes as set forth in the application.
- 2. All expenditures from this grant must be used only within the terms and conditions of the grant.
- Any funds not used or committed for the specific purpose of the grant or not used or committed within any time limit specified in the grant request shall be returned to the Foundation.
- 4. The Grantee shall furnish a written final report within six months of the awarding of the grant on the outcomes reached with respect to projects and activities financed by the grant, including a summary of funds expended, associated receipts, and three photos of the projects and activities. If the projects and activities are not yet complete, a progress report shall be submitted followed by a final report upon completion.
- 5. Any violation of the conditions set forth in this agreement will permit the Foundation to terminate any and all further distributions to the Grantee.

- 6. Grant funds shall not be used to attempt to influence legislation nor contribute to any political campaign on behalf of any candidate for public office, nor shall any funding awarded to an applicant be used for payment or administrative fees, office overhead, or other similar charges.
- 7. It is expressly understood that the Grantee takes full and complete responsibility in carrying out this project, that the Grantee holds the Foundation and the Benzie Sunrise Rotary Club ("the Club") harmless from any and all liability relating to the effectuation of this grant and further that the Grantee shall indemnify the Foundation and the Club from any claims made or actions taken as a result of this grant.
- 8. It is expressly understood that neither the Foundation nor the Club has made this grant based upon the information provided by the applicant/Grantee and that the Foundation shall not be held responsible for any consequences resulting from the making of this grant.
- 9. Publicity associated with the presentation of this grant in the form of photos, video, or news articles may be utilized by the Foundation or the Club at its discretion for promotion of the Foundation programs. The recipient organization and its members, guests or employees pictured, filmed or quoted as a result of this public relations opportunity will release the Foundation and the Club from any liability from the reproduction of this material. If a grant is awarded, the applicant agrees to include the Foundation in any appropriate promotional materials advertising this project.
- 10. This agreement shall be governed and construed under the applicable laws of the State of Michigan. Any action arising under or relating to this Agreement or the breach thereof shall be brought only in a state court situated in the County of Benzie in the State of Michigan, and the parties hereby submit and consent to the exercise of personal jurisdiction over them by such courts for the purpose of any such action.
