This Week's Program: **Public Defender Office** Presenters:

Amy Campanelli, Chief Public Defender

Following a cinematic opening featuring a pivotal scene from the 1982 film, The Verdict, starring Paul Newman and James Mason, available on your favorite streaming platform, Ms. Campanelli, Director of the **Muskegon County Public Defenders** Office, began her remarks with a brief history of Public Defense in the United States. Noting that before 1791, only those who could afford attorneys had access to legal representation; however, with the passage of the Bill of Rights and the Constitution, the sixth amendment provided the right to counsel in federal criminal cases, a right to an impartial jury trial, a public trial, and the ability to confront any witnesses. It was not until 1878, that an amendment to the California state constitution admitted women to the legal profession, and the state's first female attorney, Clara Shortridge Foltz, championed the concept of public defense to provide equal representation to the poor. She was the first female district attorney for Los Angeles and championed criminal justice including prison reform, and the right of representation for the indigent.

Recalling pivotal Supreme Court cases that are synonymous with criminal justice reform, Ms. Campanelli briefly recounted Powell v. Alabama (1932) defendants the Scottsboro Boys, 1963 Gideon v. Wainright which established the right to counsel, 1966 Miranda v. Arizona, establishing every

suspect in custody must be informed of their rights during questioning and their right to an attorney during questioning, and if they cannot afford one, that an attorney be provided for them. In 1967, Re Gault, the right to counsel was extended to juvenile cases, and in 1972 in Argersinger v. Hamlin broadened counsel rights to include misdemeanors.

Answering her question," Why are Public Defenders important?" Amy mentioned the significance of the Bill of Rights, the checks and balances within the legal system, and the aim of promoting fairness. The Muskegon County Public Defense office demonstrates this importance with their Mission, Core Values, and Vision statements of the Muskegon Public Defense.





Beginning in 2014, the Muskegon County Public Defender began practicing a holistic defense model approach to criminal justice. At the time, it was one of twenty-one offices in the country using this approach. Ms. Campanelli introduced Melinda Kotecki, Chief Social Worker, Muskegon County Public Defender Office, to inform our members about what is a holistic approach to criminal justice?

Using a Venn Diagram to illustrate the kind of issues that contribute to crime, Ms. Kotecki stated that by addressing the factors that may have contributed to an offense, the Public Defender's office can work to reduce or eliminate those obstacles so that the client can successfully re-enter society with a lesser chance of recidivism and have the resources to support them and their loved ones.

HOLISTIC DEFENSE-WHAT KIND OF ISSUES CONTRIBUTE TO OFFENDING?



Ms. Kotecki went on to briefly discuss the impacts of substance abuse and addiction, generational trauma identified by Adverse Childhood Experiences (ACES), and mental illness and the importance of addressing mental and physical health. She closed her remarks by highlighting the benefits of a holistic approach by citing data compiled by the public defender's office in the Bronx, New York which showed a 16% reduction in custodial sentences and expected sentence length by 24%, without increasing future crime. Throughout the study period, the decrease in incarceration days could yield considerable cost savings for taxpayers, provided all city boroughs adopted a holistic strategy.

Ms. Campanelli returned to the lectern with slides showcasing client testimonials, opportunities for community involvement, the Public Defender Monthly Newsletter, and closed out with a short video showcasing staff testimonials from David Williams, Chief of Probate, Kyle Jansen, Assistant Public Defender, Shawn Perry, Assistant Public Defender, Felony Division and Recovery Court Team, and Muskegon Rotarian, Kendrah Robinson, Assistant Public Defender, who for her ten years with the Public Defender office has "...been speaking for the voiceless."

Amy closed her presentation by encouraging our members to visit the Muskegon County Public Defender website.


