#### Last Week's Program Law Day Celebration by Garry Olson

Our program today celebrated Muskegon Law Day on May 1, 2015. This marked the local celebration of this event.

Law Day was established bv President Eisenhower in 1958 to strengthen our great heritage of liberty, justice and equality



under the law. In 1961 Congress designated May 1, as the official date of celebrating Law Day. Law Day programs are held nationwide. Chief District Judge Maria Ladas-Hoopes commented that the Law Day celebration in Muskegon is perhaps the best in Michigan and the Midwest.

The chief sponsor of Law Day in Muskegon is the Muskegon County Bar Association. They and numerous businesses and organizations, including both Muskegon and Whitehall Rotary Clubs provide funds and support for Law Day to provide scholarship monies and gifts to incentivize student studies of the Rule of Law through debates, speeches and essays.

Alisha Reidl from the Muskegon County Prosecutor's Office spoke about Law Day and recognized. Student contests are held for middle school through high school students. This year's theme was the 800th

anniversar y of the signing of the Magna Carta by King John of England in 1215, outlining the first establishm ent of rights and freedoms.



We were enlightened by two speeches from the high school age contests. The first presented by Rina McLain or Muskegon High School. She was the 2nd place winner of the 9-11th arade speech contest. The second given by Kevin



Pagget the winner of the 12th grade speech contest. They both spoke on the theme "Is the Magna Carta still important and relevant today."

Law Day also presents citizen awards. The first award, the Liberty Bell Award is given annually to the citizen for their work



with justice and the law locally. This year's recipient was Janet Day. Janet is a volunteer mediator with the Mediation

and Restorative Justice Center. She also has held many positions in the community.

The Frank D. Scott award was presented to Tom Cartright, Muskegon County Juvenile Court. He created the Fresh Start program for probation cases and has worked thee 23 years.

The Golden Apple Award was awarded to Marvin Bolthouse, a high school social studies teacher.

All three citizens were at our meeting to be recognized and thanked by our club.

Alisha Reidl thanked our club and the other many sponsors for participation in Law Day. It encourages students and citizens to become involved in the justice system and value freedom, the rule of law and our rights and citizens of the United States.

hundreds of book donations from Michigan.

a chicken coop. She could see where their diet was lacking in protein and chicken and eggs was a substantial addition to their diet.

Heidi is going to work with the women with gardening and sewing and cooking and baking and wherever else she is needed.

Also, at the end of this month Pam's grandson, Collin, is going with his dad to the Ukraine in a micro entrepreneurial adventure.

What does Pam think about all this? "I will miss my girls but know that their lives will be rewarded and enriched by their experiences in Kenya by all the cultural experiences and people. May God protect their group from Baylor University and may all the people they come in contact with be richly fulfilled."
