#### Meet our District Governor Nominee Designate 2024-2025

Introducting our 2024-2025 Rotary International District Governor-Brianna Scott, Rotary Club of Muskegon



Brianna T. Scott was born and raised in Muskegon, Michigan. Brianna attended Michigan State University and graduated with a Bachelor of Art's degree in Marketing. Among the honors she received were the COGIC Center Aspiring Law Student Scholarship, winner of the Delta Sigma Theta Sorority, Inc essay contest and making the Dean's list in 1996. Ms. Scott was chapter president of Delta Sigma Theta Sorority, Inc., Executive Board member of Wonders Black Caucus and a member in both the MSU Prelaw and Marketing Associations as an undergraduate student.

Ms. Scott attended Wayne State University Law School where she received her Juris Doctorate in May, 2000. She was active in variety of law school activities and she attained a final year grade point average of 3.57/4.0. She successfully competed in various law school competitions including, but not limited to Moot Court evidence competitions, acting as Article Editor of The Journal of Law in Society, **Executive Board member of Moot Court** (Director of Outside Competitions), working on the academic committee of the Black Law Student Association, and being an active student member of the Wolverine Bar Association. In addition, Ms. Scott received many scholarships and awards throughout her law school career.

Ms. Scott became an attorney in November 2000, and was immediately recruited and hired as the FIRST African American Assistant Prosecutor in the Muskegon County Prosecutor's office where her initial responsibility was handling district court cases, which included misdemeanors, ordinance violations and other hearings within the district court. However, after much success and proving herself a great trial attorney, she was promptly promoted to Circuit Court, where she handled many cases advocating for victims until she left the Prosecutor's office in 2003.

Following her tenure at the Muskegon County Prosecutor's office, Ms. Scott was hired by the law firm of Williams Hughes Corwin & Sininger, PC (k/n/a Williams Hughes, PLLC), where she embarked on the journey of a different practice of law; namely the handling of cases for municipalities, civil cases for the county, family law, corporate law, real estate and social security disability matters. As part of her practice at Williams Hughes Corwin & Sininger, PC, she was also awarded a public defender contract handling one of the abuse and neglect dockets in Muskegon County. Ms. Scott remained an associate at Williams Hughes Corwin & Sininger, PC, until 2005.

In 2005 she decided that after five years of significant experience handling all types of cases, that she wanted to become an entrepreneur and start her own law practice. Becoming a business owner, in fact the first minority (African American and female) law firm in Muskegon County was exciting, challenging, and very rewarding. Her law firm has grown significantly over the years and she now employs a full time staff of five (5).

In 2018, Ms. Scott was elected to an 8 year term on the Michigan State University Board of Trustees. A testament to the high regard placed on Ms. Scott for her professional accomplishments, ethical standards and peer recognition, Ms. Scott was recently named a 2019 Athena of the Lakeshore Award Recipient and 2021 Greater Muskegon Woman's Club Woman of Accomplishment. In 2014, she became the FIRST person of color to serve as President of the prestigious Muskegon Rotary Club. Currently, Ms. Scott serves as President of the Muskegon Heights Alumnae Chapter of Delta Sigma Theta Sorority, Inc. As well, she serves on the Boards for Access Health, Boys & Girl's Club of the Muskegon Lakeshore, Panel One of the Michigan Attorney Disciplinary Commission (County of Muskegon); and is also a member of the Muskegon Rescue Mission's Personnel Committee. Ms. Scott is also the Chair of the Muskegon Rotary Club's **Diversity & Inclusion Committee, Retention** Committee and serves as the Co-Chair for the Life Leadership Committee and the Community Service Council. In the past she has served on the following boards: United Way of the Lakeshore, Muskegon Lakeshore Chamber of **Commerce and Family Services Center** Workforce Development Center. Additionally, she serves as Legal Counsel for the International Churches of God In Christ, which is the largest African American church in the world. She is also one of the only attorneys in West Michigan to be dually licensed to practice law in the state of New York. However, her proudest accomplishment is being the parent of her son.

# THIS WEEK'S PROGRAM:



**Mona Shores Singing Christmas Tree Organizers**

Shawn is in his 32nd year teaching music, including 29 years at Mona Shores High School. He has received numerous awards in teaching and ensemble. JaiLynn is in her 7th year as an accompanist for the signing Christmas tree and the Mona Shores choirs.

Mona Shores has the world's tallest singing Christmas tree. Dave Anderson

had heard of singing Christmas trees and was sitting at St. France de Sale and felt it was absolutely perfect to establish a singing Christmas tree. Dave asked Skip Frizzel to start a Singing Christmas tree in 1979. Skip agreed due to the ability of the St. Francis de Sale to accommodate a large Christmas tree; although the tree moved to the Frauenthal Center in



2006. The initial cost for the tree was \$30,000 and was constructed be Millard Heath of Denton, Texas. Mona Shores choir travelled all over the world and used this as a fundraiser. In 2015, the entire Christmas tree needed to be replaced and Mona Shores purchased the new tree. This year is the 36th season for the tree and has been seen by 8,000 people this year. This is the most popular event at the Frauenthal Center and often tickets sell out within minutes of going online for purchase.



JaiLynn noted that this phenomenon is fueled by the parent volunteers. Six years in a row, The National Association of Music has noted that Mona Shores one of the best music education programs in the country. The only paid positions are lighting and sound design, in addition to a video production company for live streaming of the event (due to the COVID pandemic). There are early 200 adult volunteers and 50 student volunteers who make this event happen each year. Local Scouts come in and remove the first seven rows of seats for the tree to be assembled. JaiLynn notes that 13 separate committees with their own chair, which is overseen by 3 project chairs work year round on the Singing Christmas Tree. Committees include public relations, advertising, play bill design, merchandise, construction and decoration, ushers, candles, overlays, tree monkeys, nurses, student supervision and food. Tree monkeys are dozens of parents that are harnessed and strapped into the tree and are in the back of the tree with first aid kits and are able to assist the kids to help them feel safe and to get down if they do not feel well.



What makes the tree so special? It is all about the music and kids. The tree is five stories high (67 feet tall) and absolutely stunning. There are over 200 student performers, and the tree is full of singers from top to bottom. The music is carefully curated and there is an eclectic selection of holiday related music; including acapella, gospel, jazz, pop, African, classical, Hannukah, secular, sacred and often accompanied by the 50 piece Mona Shores orchestra. Shawn spends an entire year planning the music for the Singing Christmas Tree. All students do the candlelight processional signing a gospel song, Siyahamba- "We are Marching in the Light of God".



The other thing that is unique about the Singing Christmas Tree is the joy, passion, and love that the kids singing displayed by the students year after year. Shawn calls it the Mona Shores singing magic. There are only two rehearsals where all four choirs are present together and only one with the orchestra. It is a very busy schedule. It is a long standing tradition at Mona Shores and becoming a generational experience, and there is even an alumni choir.

Shawn also shared how they choose the angel. The student must be a senior. They are the kid that is not the lead in the play, may have struggles in their life, is a leader, not always the most popular student, but their spirit



and leadership shines through them; Shawn and JaiLynn sit down and determine who should be the angel.
