ART BOARD HIRE PROCEDURE

The Rotary Club of Drysdale has two custom-built twin-axle trailers each containing 20 display boards and stands as used in the Art Shows.

Each Art Board is 3m (10ft) long by 1.2m (4ft) high. The bottom edge of the Art Board, when mounted on the stand, is 1m above the floor.

PROCEDURE

CHARGES

A total of \$400 per trailer must be paid prior to the hire into the Rotary Club of Drysdale's nominated bank account:

If paying by cheque, make the cheque out to Rotary Club of Drysdale and send at time of booking to P.O. Box 123, Drysdale 3222

- The cost is made up of \$200 hire charge per trailer
- \$200 bond per trailer to be refunded into Hirer's nominated account on return of Boards after they have been thoroughly checked and in good condition

COLLECTION

1. Allocate day and time for collection.
2. Club Coordinator to meet Hirer at the Dairy in Clarendon Road, Drysdale.

Boards can only to be hired 24 hours before required and returned immediately are event held, e.g. for an event held on a Saturday boards can be collected on the Friday then returned Monday at an time agreeable to the Hirer and Club Coordinator - this can be renegotiated if the boards are to travel a distance.

PROCEDURE FOR RETURN

Hirer to slide each board out of trailer and both sides to be visually checked by the Club coordinator and slid back in, this is to be continued with all boards that have been hired.

The Hirer is to only use Art Board Hooks to attach art work to the boards. These can be purchased from Mitre 10 or Bunnings stores.

Do not use Blue Tac, Velcro, Staples, Pins etc – evidence of use of such items may result in part or total loss of bond.

The Club coordinator will check there is no damage to boards or trailers. Upon satisfactory inspection the bond will be refunded into the Hirer's nominated account within 24hours (unless weekend then earliest banking day).

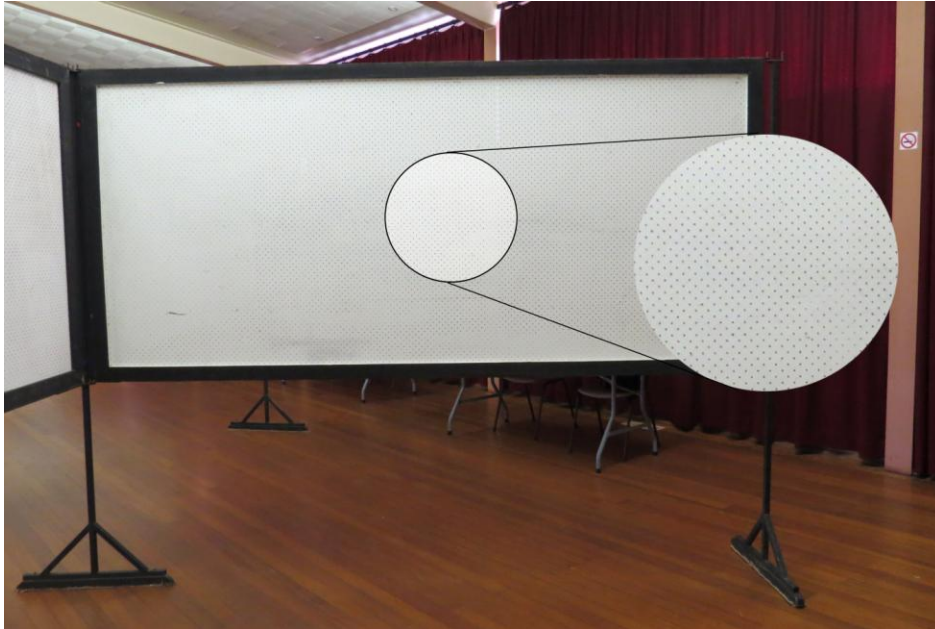

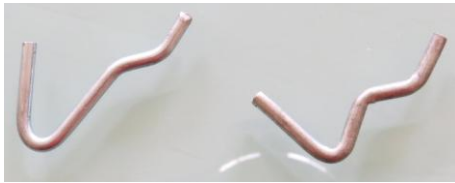

SET-UP & USE



Art boards are 3m (10ft) long by 1.2m (4ft) high. The bottom edge of the Art Board, when mounted on the stand, is 1m above the floor. Boards are perforated (see above) to accommodate art board hooks



(left) which is the only acceptable means of attaching art work to the boards. These can be purchased from Mitre 10 or Bunnings stores. **Do not use Blue Tac, Velcro, Staples, Pins etc – evidence of use of such items may result in part or total loss of bond.**
