The Rotary Club of Sacramento has once again made a remarkable difference in our local, regional and worldwide communities through the projects and programs that it supports. We are proud that a total of \$94,070 was distributed this fiscal year through this Foundation under the leadership of the Foundation Board of Trustees.

Background Facts About the Foundation

- It was established in 1971 with a bequest and gift of \$1,590 from Rotarians
- Since that time, almost \$4,000,000 has been distributed
- The corpus exceeded \$2,629,000 at the end of this fiscal year

During another tough economic year, Rotarians worked even harder and gave more generously to assure that those in need of our financial assistance continued to receive it.

Projects Funded Through the Foundation This Fiscal Year

- \$15,630 in scholarships from the Named Funds were given to six high school and college students
- \$6,250 in scholarships from the Youth Incentive Program were given to two middle and high school students
- \$16,400 in funds benefitted five World Community projects
- \$26,340 in funds were given to eight Local Community projects
- \$17,570 benefited our local Society for the Blind as a result of our annual Bids 4 Kids
- \$32,280 benefitted four local schools for the orthopedically challenged as a result of our annual Golf 4 Kids
- \$43,900 was raised by Rotarians of our Club through fines and direct contributions

Please take a few minutes to read this report to learn in more detail about the many ways in which our local, regional and world communities have benefitted from the generosity of Rotarians.



ounded in 1913, the Rotary Club of Sacramento is one of the oldest service groups in the Sacramento region which, throughout its history, has maintained an impressive commitment to community service. The Rotary Club of Sacramento Foundation, organized by Rotary members in 1971, is a California nonprofit public benefit corporation and qualifies as a charitable entity under Internal Revenue Code Section 501(c)(3).

OUR MISSION

Our Mission is to provide leadership, perpetual funding and resources necessary to support the diverse humanitarian efforts of the Rotary Club of Sacramento in local and world communities.

OUR VISION

The Foundation's Vision is to provide the means to support extraordinary accomplishments through our stewardship of a self-sustaining fund. Our recognition as a premiere organization includes our focus on supporting youth.



Legacy Circle

The Rotary Club of Sacramento Foundation has set up the Legacy Circle to recognize those Rotarians who are leaving a legacy of support to the ideals of the Rotary Club of Sacramento by helping our community.

Membership in the Circle is attained by donating a bequest from estate plans such as a contribution from wills, trusts, life insurance, charitable gift annuities or other retirement plans, evidenced by appropriate documentation.

The "Legacy Circle" name is derived from the concept that Rotarians earn their livelihood from this community, take care of their families, and eventually accumulate assets beyond their daily needs. Then, those assets go full circle as Rotarians put some portion of their net worth back into the community through planned giving to our Rotary Club of Sacramento Foundation.

Named Funds: Scholarships

Notary Scholarships totaling **\$24,878** were awarded during the 2011-2012 School year. Awards went to six graduating seniors from McClatchy, Sacramento and Rio Americano High Schools who demonstrated superior scholastic aptitude, vocational skills, leadership, community involvement and financial need. These awards were funded from the five Scholarship Funds listed above.

College scholarships are awarded to graduating seniors for full-time undergraduate enrollment at an accredited four-year college (although awards may be deferred for a two-year period while a student attends community college). Fields of study that will benefit the future of the community and foster the principles of Rotary are encouraged. Scholarship applicants may not be the children of Rotarians.

Bids for Kids was held at the Hyatt Regency in downtown Sacramento with the inimitable Rotary Rooters providing music during the Silent Auction.

In the weeks before the gala, ophthalmologist Dr. Barbara Arnold taught art classes for students with limited vision at the Crocker Art Museum. Several sight impaired individuals attended Rotary Club of Sacramento luncheon meetings and provided testimonials about how the programs sponsored by The Society for the Blind had bettered their lives.

World Community Service

The World Community Service Committee (WCSC) oversees funding for international projects identified by members of the Rotary Club of Sacramento.

There is a preference to fund projects that support the health and care of children, including community sanitation, water needs, education, community development and food production.

Funds can potentially be augmented by matching funds from Rotary District 5180 and Rotary International.

SAFE BLOOD AFRICA

RCS partnered with the Rotary Club of Ilorin in Kwara, Nigeria, to place a blood bank in the local public hospital. Funding was approved by district 5180 and RI in May 2012 and installation is eminent.

PHILIPPINES COMPUTER PROJECT

RCS completed a computer project in the Philippines with the Rotary Club of Calauag. Thousands of people of all ages will benefit from our donation of computers.

CAMBODIA WATER PROJECTS

Between December 2011 and February 2012, Journeys Within Our Community was funded by RCS to work in the village of Duon, Cambodia, and achieved the following:

- 15 new family wells were drilled
- 94 wells received essential repairs
- Water filters were distributed
- Hygiene was taught

RCS also partnered with Phnom Penh Metro Rotary Club to provide several hundred ceramic water filters to homes and two schools in the village of Pou Murnkof, Cambodia.

ETHIOPIA WATER PROJECT

The successful completion of the water project in Acheber in the Soddo Guraghe region was financed by RCS in partnership with the East African Village Outreach and the Addis Ababa West Rotary Club. This project provides clean water to more than 5,000 people in four villages.

JAMAICA DENTAL RCS contributed to den

RCS contributed to dental services provided to villagers in Jamaica.

COSTA RICA WHEELCHAIRS

RCS participated in a district wheelchair project in Costa Rica that provided over 500 chairs to incredibly grateful recipients.

The Youth Incentive Program (YIP) matches at-risk children with Rotary Club mentors who help them develop into productive and confident young adults. Mentors give freely of their time in supporting students to establish and meet academic, athletic, social and self-esteem goals.

Upon graduation from high school and successful completion of the YIP program, each student is eligible to receive a major scholarship toward continuing their education.

This year, the Foundation awarded **\$7,500** in YIP scholarships.

Since the inception of the YIP Program, the Foundation has awarded \$110,726 in YIP Scholarships.
