Paul wanted to invite everyone to the District Assembly being held on Saturday, April 2nd ARDEN ARCA at Inderkum High School, from 8:30 until noon. There are several seminars to choose from. It is a very good way to learn a lot about Rotary and specific job areas you may want to learn about to be able to do your best for Rotary. See Paul for information.

Steve asked what ideas we had to memorialize Dan McCallum or help his family. Many suggestions were made, but it was decided a donation to Ducks Unlimited would be made and then we would see about having one of the upcoming Eagle Scout projects include a bench in his honor.

Thank you Sheila for putting new numbers on the back of the badges—they help us keep the box organized!

Prez Steve introduced Kathleen Kelleher, the Sacramento County Assessor. Kathleen spoke from a presentation about the 2016-17 Assessor's Report. It helps explain what her office does. They assess properties for Property Taxes. They locate taxable properties, identify the owners, determine the estimated value. Once these are determined the item is turned over to the Tax Collector to issue bills, collect taxes, issue refunds, handle appeals and record documents.

Prop 13 went into law in 1978. It rolled back values to the 1975 value and set the property tax as 1% of assessed value. Properties are assessed when they change ownership or there is new construction. A reassessment cannot be higher than 2%. Prop 8 fixed what was left off in Prop 13, the ability to lower the property tax when the assed value exceeds the current value of the property. The reduction is temporary and would be reviewed annually. The Assessors Office tries to proactively notify reductions.

You can contest an assessed value between July 2 and November 30th. The values and forms are on the Assessor's web site. You can also see your assessment on the web site. Assessment appeals are independent of the Assessors Office, the Board of Supervisors handles them. There is a \$30 fee.

How do you know to assess a property? The Assessor's Office uses Residential Property listings/sales, regression analysis and trends. In a reassessment, only the new item, a pool for example, would be added to the current assessment the entire property would not be reassessed. Only in the case of a "substantial equivalent of new" remodel would the property be reassessed.

There are several exclusions to Prop 13. There is a Parent to Child or Grandparent to Grandchild (if the parent is deceased) exclusion which allows the child to retain the Prop 13 assessment. You can also transfer your base year assessment if you are over 55 years old and purchase a lower cost property within the same county (some counties allow from other counties but not Sacramento.) There is also something coming up called a Homeowners Exemption to postpone property tax but it won't be until 2017.

The Assessor's Office gets a copy of every building permit and uses them for reassessments.

Commercial properties may not continue to qualify for Prop 13 rates, there is a growing momentum to

Have them not follow the same Prop 13 guidelines. The many exclusions have made Prop 13 harder to justify and there is talk about moving away from the Prop 13 model. Thank you Kathleen for an interesting presentation!
