



Corporate Membership Application

Corporate membership allows employees of a business or organization to join the Ithaca Rotary Club with up to three members. Organizations can participate in Rotary with greater flexibility in who from the organization attends club meetings, community service projects and social events.

- Corporate membership is open to companies, nonprofits and governmental agencies.
- One primary member from the organization will join the Ithaca Rotary Club at the annual dues rate of \$300, payable in installments every six months.
- Up to two employees of that organization can also join at the rate of \$150 a year for each member, payable in installments of \$75 every six months.
- All three members will be official members of the Ithaca Rotary Club and will receive the club newsletter, email notifications and Rotary International Magazine.

Member Expectations

- Members attend club meetings. Corporate members may alternate attending meetings or attend together.
- Members participate in community service projects.
- Members will join at least one club committee.

If accepted for membership, a primary member from our organization will pay annual dues of \$300 and affiliate members will each pay annual dues of \$150. We subscribe to the principles of Rotary International and give permission to the club to publish our names to its membership.
