





Voters want bipartisan solutions


National climate solutions should be bipartisan

The vast majority of American voters think it is important that any national climate solution be bipartisan. Climate can and should be a bridge issue, where parties work together to find effective solutions that are good for America.



Voters support a carbon fee with dividends

Two-thirds of American voters support a fee on carbon with revenue returned to households as a regular dividend check. There is support across all parties including a majority of Republicans and three-quarters of Republicans under 40.

A carbon price should be part of the solution.









Charge a fee on fossil fuels – rises every year


Return 100% of net revenue to households as a monthly dividend






Congress needs our help






