Please note that all fees are non-refundable. The space **does not** include a table, chairs or tent. You must bring your own. As the event is outdoors, we recommend bringing a tent. Spaces are 10x10. New this year – the festival gates open to the public at 11 am with music starting at 12 noon. Electric is **NOT** available. Please note that Blues & BBQ is on, rain OR shine!

Applications will be accepted up until Saturday, September 7, 2019. Applications received after that date cannot be guaranteed a space.

- 1. All vendor/sponsor spaces are available for one or both days. Craft Fair spaces are available for \$50 for one day, \$80 for the weekend. Exhibiting Sponsor spaces are available to local businesses for \$225 for one day, \$400 for the weekend.
- 2. Vendors participating both days MUST break down their booth on Saturday night and set it up again on Sunday morning. We have no storage available for vendors and are not responsible for anything left on the property overnight.
- 3. Entry to the festival for setting up will be on Saturday and Sunday morning starting at 10 am. Set-ups must be completed by 11am. All vehicles must be off the festival grounds no later than 10:45 am. All vehicles are asked to park in the large parking field, NOT behind the kids' area or in the fire department parking lot. No vehicles will be allowed on the ground between 11 am and 7 pm. **No early breakdowns before 6pm are permitted**. Any vendor/sponsor who would like to breakdown at 6pm will not be able to bring their car onto the festival grounds.
- 4. Non-profits are welcome to join us this year at no charge pending Patterson Rotary Club approval and space availability. Non-profits may sell merchandise but may not sell raffles.
- 5. Political organizations are not permitted.
- 6. Patterson Rotary and Patterson Fire Dept personnel reserve the right to ask any vendor/sponsor(s) to leave the grounds if the rules and regulations are not met. This includes any confrontations between sponsors, crafters, and/or customers. Refunds will not be made due to any confrontation. We also reserve the right to ask you to remove any items we find objectionable.
- 7. Patterson Rotary will only accept one booth per vendor company (ex: only 1 Thirty-One booth). Vendors may team up with fellow consultants to share a booth.
- 8. All confirmations will be done electronically by email. Booths are considered confirmed when a signed agreement and payment is received via credit card through our website. Payment links will be emailed out upon application acceptance and payment must be made within 7 days.
