Community Service 2: Bob Berger

Bob is looking for "out of the box" ideas to make our Club better. Since Club Board elections are coming up in December, Bob recommends that the four outgoing board members meet with the newly elected board members to ensure continuity and knowledge is shared. In addition, it would be helpful if the President Elect (Paul Cunha) could assign the new board members to their area of responsibility soon after the election so they can meet with the person they are replacing.

International Service: Dorthe Wright

On October 11, 2023, Dorthe sent Club Board members the following information to clarify her report:

The International Grant Committee met on September 28, 2023, and voted to allocate \$1,000 to a water check dam project in India. (This is in addition to the \$1,000 PWR contributed last year to the same project.)

The committee also voted to allocate \$2,000 to the Marikana community garden in South Africa, where PWR is the international host club. Another \$2,000 was allocated to a WASH Project in Guatemala. Both Global grants are still in draft. PWR President Roger Gilleland will receive requests to fund the grants once they have been approved by RI.

\$5,000 of the \$10,000 budget has been committed. The next IGC meeting is in December 2023. District Foundation dinner is November 18, 2023. The Club will pay \$40 of the \$80 cost for members. Guests are \$80. The location is the Citrus Heights Community Center.

Youth Services: Randy Burton

Randy clarified that Rotary Youth Exchange is not in Youth Services.

Randy will check with Don Rodes, the previous board member assigned to Youth Services.

Public Image: Maria O'Neil

Maria advised that PWR Foundation President Jesse Nix and Club President Roger Gilleland have discussed and support the need for new effective social media strategies, both for the Brewfest and the Club projects. Maria stated the importance of having a social media contact that understands our Club and priorities to freshen up ideas, appeal and outreach to the public. Maria asked for approval to revise the social media contract effective October 1, 2023 to September 30, 2024 with new pricing estimated at \$7,200 per year. Motion by Paul Cunha to approve the new contract for social media contact. Second by Greg Garcia. **Action:** approved unanimously.
