SPOUSAL MEMBERSHIP

1. A spouse or partner can become a member, with dues of \$50 per quarter, by having a spouse or partner who is already a club member paying full dues.
2. A couple can apply and be approved for membership by meeting the same qualification requirements as a single member. One spouse must pay full dues and the other will pay the amount set by the board on an annual basis,

which will be an adequate amount to cover their RI and District dues, currently \$50 per quarter.

3. A spousal member will be an active member of the club and will be reported to RI as active.

A Corporate Membership allows for two memberships: one for the CEO and one for an individual designated to attend in the CEO's place. The CEO may be the active member as his or her time and priorities permit. The CEO, if not an active member, shall not have attendance or other requirements, but shall receive all the privileges and opportunities of an active membership. The active member shall have the same requirements and opportunities of any other club member. A one-time initiation fee of \$500 is billed upon approval.
