## 2015 – 2016 Rotary Year

Rotary Club of Superstition Mountain's (Club 1246) was chartered by Rotary International (<http://www.rotary.org>) on January 9, 1961. Rotary International is the world's first service club organization having started in February 1905. Rotary International has more than 1.2 million members in over 34,000 clubs worldwide. Rotary's goals include five Avenues of Service:

Club Service

Vocational Service

Community Service

International Service

Youth Service: INTERACT Clubs (Age: 12 - 18) and ROTARACT Clubs (Age: 18 - 30)

Members of Rotary Clubs work locally, regionally and internationally by volunteering to support education and job training, provide clean water, combat hunger, improve health and sanitation, and eradicate polio under the motto "Service Above Self".

### Club Fund Raising Projects:

Our members and winter visiting Rotarians work a number of community projects with over 1,000 hours of community service. The projects include the following:

- Annual Rotary Golf Tournament held each January at Gold Canyon Golf Resort
- Lost Dutchman Marathon held each March in Apache Junction
- Lost Dutchman Days Rodeo held for three days each March in Apache Junction
- Apache Junction Chamber of Commerce - Festival of the Superstitions in Apache Junction
- Dictionary Project which annually distributes dictionaries to all third graders in the Apache Junction Unified School District

**Meetings:**

**Membership:**

**Initiation Fee:**

One-time fee is billed upon approval of membership as follows:

A Corporate Membership allows for two memberships – one for the CEO and one they designate to attend with they are unable to attend. The CEO may be the active member as his or her time and priorities permit. The CEO, if not an active member, shall not have attendance or other requirements but shall receive all of the privileges and opportunities of an active membership. The active member shall have the same requirements and opportunities of any other club member.

**Attendance:**

Rotary International expects a minimum attendance of 50% which can be achieved by making up missed meetings at other Rotary Clubs or by attending an internet meeting hosted by the Rotary eClub of the Southwest USA (<http://www.recswwusa.org/>). Make ups can also be accomplished by:

- Participating in person in our club fund raisers, service projects or socials.
- Attending a Board of Directors meeting.
- Attending a District meeting or training session.

Our club is not “hard line” on the issue of attendance, but we believe that to be truly involved in fellowship; networking opportunities; and community involvement members should attend the meetings.
