





Our Speaker last week was Steven Harrell with the Water is Basic.

The mission of "Water is Basic" is to empower the local leadership of Southern Sudan to provide the gift of clean water to their own people. Decades of war, poor land management and drought have left the people of Sudan facing a desperate water shortage. Over 70 % of the population has no access to safe water. According to the UN, waterborne diseases kill 4 children worldwide per minute. According to USAID, 1 in every 4 children born in Southern Sudan dies before the age of five. Half of those deaths are from water-related illnesses.

Due to the civil war, millions of Sudanese fled the country. Now with the relatively stable peace, Two hundred and fifty thousand Sudanese refugees are expected to have return to their homeland in 2007 alone, but they are returning to areas with no infrastructure or services, particularly water and sanitation. 20,000 wells will need to be drilled in Sudan to provide minimal (though not adequate) support.

An average home in the west uses over 100 gallons of water each day. In contrast, an entire African family uses about 5 gallons of water each day. Just one flush of a toilet in the West uses more water than most Africans have to perform an entire day's washing, cleaning, cooking and drinking.

In March 2006, a consultation of Sudanese pastors determined that their major health priority should be to provide clean water to the people of Sudan. It is the goal of Water is Basic to come alongside these Sudanese leaders and provide them with the equipment needed to drill wells.

The vision of Water is Basic is to see a well drilled in every village in Sudan. Funds have been raised to purchase 2 drilling rigs. Sudanese nationals have been trained to drill, operate & repair their own water wells. The cost for a complete drilling rig costs \$180,000, but a rig can drill one well every week for \$3,000 each.

Rotary Basics - The Organization of Rotary

Rotary is essentially a grassroots organization, with most of its service efforts being carried out at the club level. The district and international structure is designed to support the clubs and help them provide more service in their local communities and abroad.

Clubs

Rotarians are members of [Rotary clubs](#), which belong to the global association Rotary International (RI). Each club elects its own officers and enjoys considerable autonomy within the framework of Rotary's constitution and bylaws.

Districts


Clubs are grouped into 531 [RI districts](#), each led by a district governor, who is an officer of RI. The district administration, including assistant governors and various committees, guides and supports the clubs.

RI Board

The 19-member [RI Board of Directors](#), which includes the [RI president](#) and president-elect, meets quarterly to establish policies. Traditionally, the RI president, who is elected annually, develops a theme and service emphases for the year.

The Secretariat

Rotary international is [headquartered](#) in the Chicago suburb of Evanston, Illinois, USA, with seven international offices in [Argentina](#), [Australia](#), [Brazil](#), India, [Japan](#), [Korea](#), and [Switzerland](#). The office for RI in Great Britain and Ireland ([RIBI](#)), located in England, serves clubs and districts in that region. The Secretariat's chief operating officer is the RI general secretary, who heads a 650-member staff working to serve Rotarians worldwide.



Taking the pennant




One of the more colorful traditions of Rotary is the exchange of club banners. Rotarians traveling to distant locations often take banners to exchange at make-up meetings as a token of friendship. Many clubs use the decorative banners they have received for attractive displays at club meetings and district events.

By 1959, exchanging banners had become so popular that the RI Board of Directors was concerned the practice would be a financial burden on clubs. It urged Rotarians to “exercise discretion, moderation, and measured judgment in making provision for such exchanges.”

The approximately 20,000 banners in the [Rotary History and Archives](#) collection reflect clubs' hometown pride and their connection with the international organization.

In addition to incorporating the Rotary emblem, banners often include symbols or imagery of a club's town, region, or country. Others represent local craftsmanship or cultural traditions by displaying leatherwork, weaving, embroidery, or hand-painted designs.
