Today's Program: LISA WEISSLER: THE SEA PARTY & THE COASTAL ZONE MANAGEMENT INITIATIVE

With a forestry degree from Southern Illinois University, Lisa Weissler came to Juneau

for a summer job as a forester with the U.S. Forest Service. That was over 32 years ago. From that summer spent tramping through Alaska's Southeast rain forest, Lisa's career path took an opportune turn when from 1981 until 1988, she served as a

legislative assistant for the Alaska State Legislature. This led to a job adjudicating administrative appeals for the Department of Natural Resources' commissioner, and then to law school.

In 1994, at the age of 38, Lisa graduated with a law degree from the University of Oregon. With degree in hand, she worked several years for the state's coastal management program as a project analyst, advising decisionmakers on coastal management program implementation and related policy issues, and overseeing implementation of projects funded

by the Coastal Impact Assistance Program.

Following a year of clerking for the honorable Justice Carpeneti during his last year on the Superior Court bench, Lisa served as an As-

sistant Attorney General for the Alaska Coastal Management Program, representing the state in administrative appeals of agency decisions to Alaska courts, writing regulations implementing the coastal program, and drafting opinions addressing coastal program and other natural resource legal issues.

In 2002, Lisa returned to the legislature, serving as staff counsel and advising legislators on complex policy issues, including the state oil and gas fiscal regime, natural resource related legislation, development of a natural gas pipeline, and the state's coastal management program.

From 2007 until retiring from the state in December of 2011, Lisa worked for the Alaska Department of Law as an oil, gas and mining attorney. She advised the Department of Natural Resources, Division of Oil and Gas on legal issues related to development of an Alaska natural gas pipeline, natural gas storage, and implementation of state and federal oil, gas and mining statutes and regulations.

Even in her retirement, Lisa is staying active. She worked yet another legislative session in 2012, advising legislators on oil and gas tax legislation and shepherding bills through the legislative process. She's currently volunteering her time as policy director for the Alaska Sea Party and the ballot initiative to bring a coastal management program back to Alaska.

Russia Far East Wheel Chair Project: The Rotary Club of Juneau is a key player in the current effort to deliver wheel chairs to Novosibirsk Russia sometime later this year (or early next year). The window of opportunity is being driven by Russian customs, which has received the container of 5000 wheel

chairs and is processing the chairs for clearance. This process could take from three days to three months. Norm Richards of the Sitka Rotary Club (District Wheel Chair Project Chair) is our Alaskan point person for this effort in conjunction with the Rotary Club of Novosibirsk. There is very strong interest from Juneau, and intent to put feet on the ground in delivering these wheel chairs when the opportunity presents itself. It is expected that we will have approximately six club members travel and augment the \$2500 the club has invested so far in this project.

Rural Alaska International Project: Our club is researching the start-up of an international project for rural Alaska. The goal is to host an international effort to provide specific support in funding, knowledge and hands-on help in providing some much needed relief to a native village in the interior western coastal regions of Alaska. At this time we are engaging State legislators to define where the most help is needed. This project has huge potential and the opportunity for many 5010 District clubs to participate in — at all levels of support. Some ideas on this project include clean water, schools, domestic violence intervention, and village relocation and/or community building rehab. We are also looking at international club partners who may wish to join forces with our club to work on this effort in rural Alaska. Some current thoughts are to tie in with some Mexican, Russian, Africa and South American clubs we have assisted over the years on their projects and to explore "sister city" clubs of Alaska towns.
