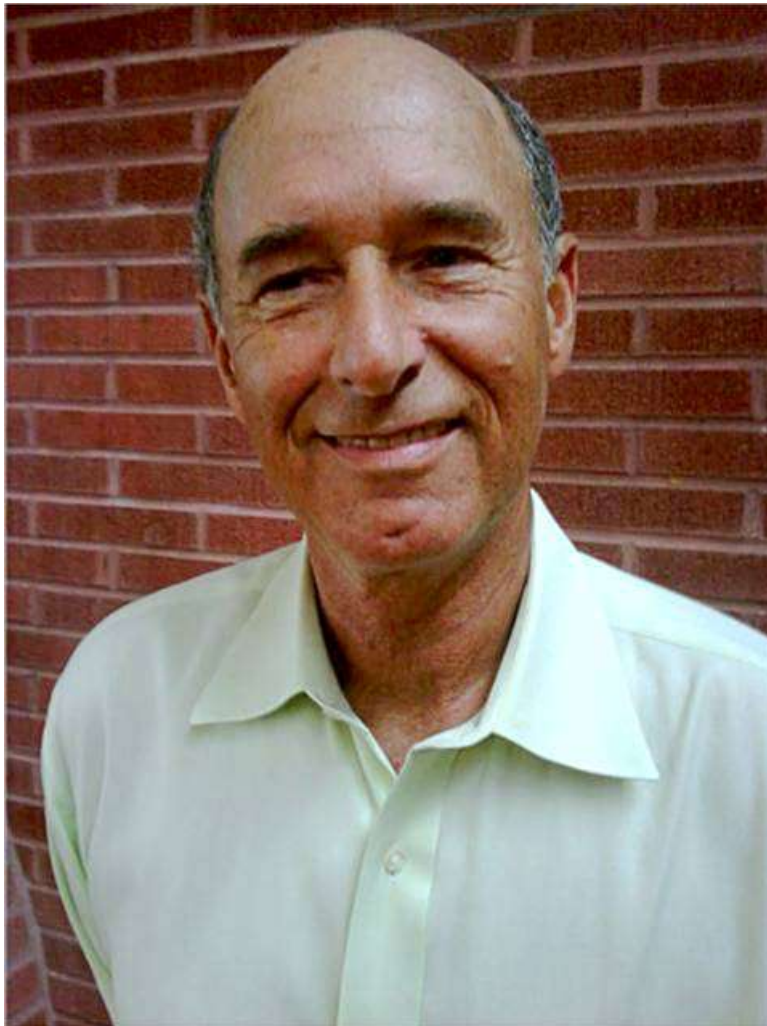

### **Michael Shultz "The Costs of a DUI"**



**Michael L Shultz, Esq.** worked as a public defender 5 years after graduating from USC and Loyola Law School. His first case was a man who already had 37 DUI convictions. He didn't think he had a chance to winning the case but the jury only 11 of 12 jurors voted guilty, which resulted in a hung jury. The one juror did not believe anything any police officer would say so it would have been impossible for the prosecution to convict anyone with that juror. The defendant went back to jail to await a second case and was later dismissed for "Time served." Mr. Shultz, a Malibu resident, who also works as a judge in small claims court, later went on to specialize in defending traffic cases, especially DUIs.

Sometimes people ask him "How can you defend this scum?" He replies that everyone is entitled to a defense in our justice system. If he didn't do it someone else would. Then they ask him how

does he do it? How can he get his clients off? He says that you can expect that if you get a DUI it's going to cost you in many ways, besides paying for a lawyer. Insurance premiums, if you can get insurance, are minimally going to double. The fine for a first offense in the court is going to be \$1600, but it could also result in suspension of drivers license, which might also result in loss of job and then lead to loss of marriage, etc. Attorneys fees vary, but with an expert witness in a jury trial the fee may be \$6,000 to \$7,000.

The techniques he uses to defend his clients include trying to find a discrepancy in the police report (sometimes officers will just copy and paste the same information from various cases and forget to change certain details pertaining to the case in question). If there is a video that shows the client didn't have slurred speech at the time of the arrest and the report says they had slurred speech that would be a discrepancy he would jump on. Also, everyone is entitled to a "Speedy Trial," and if that is not given it could be cause for dismissal. He also used 4 Amendment rights for probable cause for search. If there was no reason stop the suspect, even if he was drunk but acting normal with nothing wrong with his vehicle then that could be used to defend his client. Another technique he uses is advising clients to delay as long as possible taking blood test for alcohol. Drivers must submit to either a Portable Breath Tester (PBT) or taken to a hospital to have blood taken to measure alcohol content. The longer the time has elapsed between drinking alcohol and the test, the lower the blood alcohol level will be. It will always take longer to take blood than to use the PBT so opting for the blood test will usually result in a lower level. If the blood alcohol level is greater than .08, he still may be able to plea bargain in certain counties. Ventura County does not allow plea bargain if the blood alcohol level is .08 or more.

Remember the adage: If you drink don't drive and if you drive don't drink. Remember designated drivers and taxis, or going to sleep until you sober up, wherever you are.

### **Other News and Guests from the Last Malibu Rotary Club Meeting**

Although the meeting of August 19<sup>th</sup> was supposed to be the only meeting of the month where the Malibu Rotary Club was going to meet in its traditional meeting place in the Fireside Room of Pepperdine University it turned out that the Rotary Club was displaced even on that day, and met instead in the main cafeteria room. Not only were there no tables in the Fireside Room, the large cabinet that had been in the room that housed Malibu Rotary and Malibu Optimists gear (flags,

### **Editorial: Is Pepperdine Divorcing Rotary?**

Did you ever see one of those movies where couples are breaking up? Typically the couple had been living in an upstairs apartment in New York, and the wife is in the apartment above throwing the guy's belongings out the window, on the guy, who is on the ground a couple stories below, ducking golf clubs, TVs, and items of his clothing.

For years there has been a strong bond between Rotary International in general and the Malibu Rotary Club in particular, and Pepperdine University. Both have international locations and a commitment to try to make the world a better place. Rotary has principles based on the 4 Way Test and Service Above Self. Pepperdine strives to have an ethical conduct and service in what it teaches. Chancellor Emeritus Charles Runnels has been a long time member of L A 5 Rotary Club. Executive Vice Chancellor **Larry Hornbaker**, retired from Pepperdine University in December 2002 after serving the University for more than thirty-three years. While he was at Pepperdine, the University encouraged him to become a Rotary leader and he became Rotary District Governor. Other earlier prominent names of Pepperdine University that were Members of the Los Angeles Rotary Club were William S. **Banowsky** was a former president of Pepperdine University from 1968 to 1978. The Malibu Rotary Club sponsored the Pepperdine Rotaract Club, which became one of the largest clubs on campus. Three out of the last four years Pepperdine students have been awarded Rotary Ambassadorial Scholarships to study abroad (worth about \$23,000 each). The Pepperdine University Website lists at least 105 references to Rotary on its search engine.

Malibu Rotary Club currently has 11 active members and 4 honorary members and 3 of the active members, David Baird, Dennis Torres, and Chris Bauman, and one honorary member, Connie James, all have worked at Pepperdine for years. The Malibu Rotary Club has been meeting in the Fireside Room at Pepperdine University for a couple decades. Pepperdine was gracious enough to allow the Malibu Rotary Club to store its meeting equipment (name badges, flag, speaker gifts, stationary, bell, gavel, etc) in a locked storage cabinet in the Fireside Room.

At the beginning of the summer the Malibu Rotary Club was informed about the possibility of extra charges from Pepperdine for setting up the Fireside Room, and we had been discussing the consequences of that in recent months. We had considered Pepperdine our home. What the Malibu Rotary Club was not expecting was the e-mail below that was sent to Chris Bauman on Friday, August 14 from Maureen, who is in charge what's going on in various rooms on the Pepperdine campus:

**Subject:** RE: Fireside Room Cabinet

Please know that the cabinet has been removed from the Fireside Room. This happened today. Apparently, the Rotary belongings have been removed and placed in the Fireside Room storage area. It is my understanding that this directive came from the Chief Business Officer, Edna Powell's Office. Sean Mike with Human Resources was involved as well, x6213. Maureen

No thirty days notice—no notice at all that this was going to happen. It was only about a year or so ago that Bob put shelves in the cabinet in the Fireside room so that Rotary belongings could be neatly filed there. Forget that. Rotary your outta here! Is it something we said or did? Duck, here comes another box of stuff.

### **Malibu Rotary Club Meeting Place and the Options at Pepperdine University**

Earlier in the summer Chris Bauman outlined some of the conclusions we had about our meeting place at Pepperdine:

In short, they will continue to set up the tables as usual through the summer. If, during the summer, a situation arises where they are unable to set up the room for us due to the room being occupied the day/evening prior, I will receive a phone call alerting us of the situation. We can then elect to either take the room 'as-is' or pay the additional set up fee of \$68.



We also spoke of the possibility of them checking a key out to me to have access to the tables in the instance we accept the room 'as-is' and there are no tables available. We would then set up our own tables; which is not to assume that we would not possibly face the situation of having 100 chairs set up in the room from the prior event.

After the summer, In August, we can revisit the longer term solution and decide the best route.

Most of you know how strongly I feel about the Project TRIUMPH program conceived by Ilan Magdali of the Newbury Park Rotary Club. The program brought 10 teenage Arab and 10 teenage Jewish students from Israel to a leadership camp in Simi Valley where they all learned to work*

*together, develop leaders skills before returning to Israel to use what they learned back home. Most of us feel helpless in trying to find a solution to the constant war in the Mid East, but at least this program is trying to do something, In the last issue of The Malibu Rotary Club Surfwriter I had written about e-mail communications I had had with Frances Fuji of the Project TRIUMPH organizing committee. She had written*

“In light of the current economic climate and more challenging environment for securing grant monies, instead of hosting students this year, we are taking the opportunity to strengthen infrastructure in Israel and to establish collaborative relationships with aligned organizations.

Upon our request, Shaul, from the Rotary Club of Haifa, provided us with a budget and proposal to hire a part-time facilitator to be responsible for year-round support of both new Project TRIUMPH students and alumni. We are sending money to contribute to the facilitator’s salary, and she has already begun meeting with the kids there.

We are excited about prospects for 2010 and beyond (the plan is to resume bringing kids over in 2010, assuming that we can raise enough funds in 2009) and believe we will emerge from this fallow year with an even stronger, more well-rounded and promising program than ever before.”

In a subsequent e-mail she had written about what some of the student alumni of the Project TRIUMPH program (many of whom we had met when they were here) were currently doing after participating in the Project TRIUMPH program:

“Our greater vision is to inspire leaders of tomorrow by imparting wisdom and broadening the perspective of high school students. Our first year students, who were here in 2006, are now in the army or beginning to build careers. We have stayed in contact with some of them through Facebook. Very soon, their generation will be making pivotal choices that will impact not only their region, but the world.

We're proud of all the young people we've worked with, and we thank you for your belief in them.
