Marshall Glick, Esq:

"Disinheriting Uncle Sam (and Protecting Your Assets Against Creditors)" -- Update on Wills and Trusts



MARSHALL A. GLICK has practiced law for over 39 years and has 18 years of extension teaching experience at U.C.L.A. and at other U.C. campuses. His teaching subjects have ranged from Advanced Estate Planning, Real Property Law and Corporation Law courses conducted both on and off campus, and in extension classes given at the U.C.L.A. School of Law. He is a graduate of the University of California, Santa Barbara, and the U.C.L.A. School of Law. He has lectured on a statewide basis various

campuses of the University of California, speaking on such topics as "Advanced Estate Planning -- Transferring Property Into Revocable Living Trusts" and "The Mechanics Of Financing -- Promissory Notes and Deeds Of Trust".

His topic at the Malibu Rotary Club meeting on June 3rd was "Disinheriting Uncle Sam" and the importance of protecting your estate against creditors, including but not limited to the IRS. He also pointed out the importance of updating your Will and living trust to reflect the most recent and anticipated revisions to the federal estate tax exemption.

In addition talked about including two provisions that very few have in their Will or living trust:


- 1. A "no contracts" clause, stating that under no circumstances would you leave your estate to anyone not specifically mentioned by name or classification (such as a niece or nephew) in you Will or living trust. The inclusion of this clause may help prevent health care givers from coming up with a "new Will" after you die that leaves all or part of your estate to your caregivers and disinherits your family members. In his hand out Mr. Glick gave an example of such a clause.
- 2. A "live-in home care" provision, that provides that as long as you are able to make your own decisions, you prefer either to remain in your own home or in the highest quality long term or assisted living facilities, with the persons coming into your home or facility to provide for your care and maintenance as needed. He also gave a sample of this clause.

Mr. Glick said that most trusts provide that the surviving spouse is able to act alone as the sole trustee. Unless the estate is smaller than the federal estate tax exemption in effect at the time of the first spouse's death, this common provision is not recommended for estate tax reasons to be explained. It is important for estate tax purposes to provide a co-trustee acting with you if you are the surviving spouse.

Mr. Glick also said it is important to have a "HIPAA" documenting authorizing the disclosures by doctors and hospitals of your confidential health care information to the persons designated on that form. He also said that it is important the current California version of the Advance Health Care Directive (the document that Terri Schiavo's family in Florida wished she had signed).

Other points made, in addition to updating Wills and Trusts to reflect changes in regards to your family, are making sure that all of your assets and properties are held in the name of your living trust in order to avoid probate and the importance of having an irrevocable life insurance life insurance trust when there are substantial assets.
