PROGRAM - The F-35, Eric Schnaible

Eric Schnaible is an F-35 International Communications Manager with the Lockheed Martin Aeronautics Company, located in Fort Worth, Texas. In this position, he is responsible for international public and news media communications activities for Lockheed Martin's F-35 Lightning II Foreign Military Sales (FMS) program with Israel, Japan, the Republic of Korea (ROK), F-35 program partner Italy and F-35A/B/C System Development and Demonstration (SDD) flight test verification and software development.



Prior to joining Lockheed Martin in March 2013, Eric was a U.S. Government civil service public affairs officer for the U.S. Department of Defense (DoD)'s Defense Threat Reduction Agency (DTRA), Fort Belvoir, Va., serving as advisor to the Senior Executive Service (SES) director for strategic engagement and workforce communications.

Eric has more than 30 years of international communications experience, including his active-duty military service, globally-assigned as a U.S. Air Force Public Affairs Officer (PAO). He was hand-selected to and ably led his staffs and teams in a variety of strategic public communications and senior leadership positions, including as: the Director of Production for the DoD's Defense Media Activity (DMA) at Fort George Meade, Md.; the Director of Public Affairs for U.S. Air Forces Central Command (AFCENT), Al Udeid Air Base (AB), Doha, Qatar; the Director of Public Affairs, HQ Air Combat Command (ACC), Langley Air Force Base (AFB), Hampton, Va.; the Director of Public Affairs, HQ U.S. Forces Japan (USFJ), Yokota AB, Tokyo-Fussa, Japan; the Director of Public Affairs, Space & Missile Systems Center (SMC), Los Angeles AFB, El Segundo, Calif., and as the USAF "Thunderbirds" F-16 Aerial Demonstration Squadron Public Affairs Officer (Thunderbird #12), Nellis AFB, Las Vegas, Nev.

Additionally, he held several diverse and increasingly challenging public affairs leadership duty assignments including at Edwards and Vandenberg AFBs, California; Wiesbaden and Ramstein ABs, Germany; Woensdrecht and Soesterberg ABs, the Netherlands; HQ Multi-National Force-Iraq (MNF-I), U.S. Embassy-Baghdad, Iraq; on the USAF's Air Staff, the Pentagon, Arlington, Va., and at Davis-Monthan AFB, Tucson, Ariz. He retired as a Colonel (O-6) in May 2012, following 27 years active duty service, 1/3+ of his time served or deployed overseas.

Eric, a native of Hewlett, Long Island, N.Y., holds a Bachelor of Science degree in Mass Communications from Norwich University (The Military College of Vermont) in 1985 and a Master's degree from Golden Gate University (Calif.) in Public Administration/Human Resource Management in 1988. He graduated the DoD's Defense Information School (DINFOS), earned the military combat zone service Bronze Star Medal (BSM) among multiple other Air Force and Joint decorations and completed professional military education studies with the USAF Air War College (AWC), Air Command and Staff College (ACSC), Squadron Officer School (SOS) and a competitively-selected Air Force Education With Industry (EWI) fellowship in Crisis Communications with Hill & Knowlton Public Relations, Inc., in New York, NY.

He and his wife, Stephanie; son, Samuel and their three rescue dogs and two cats, live west of Fort Worth, Texas.

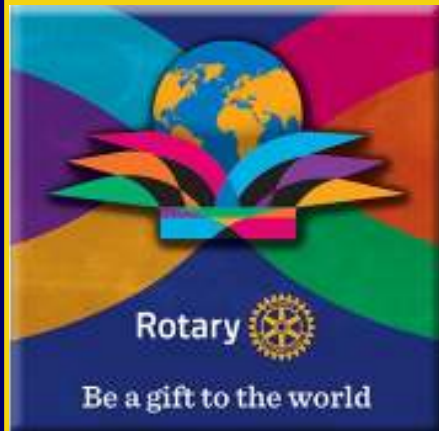

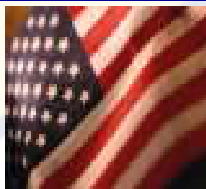
