I certify that the displayed items are my original art work and that the work has **not** been purchased from other sources. (Artists are encouraged to report to the Rotary Club any concerns regarding buy & sell products that are being exhibited in the show; numerous/recurring complaints regarding buy & sell artists will be seriously considered during future application selection.)

Jewelry & Textile Artists - Priority is given to Renewing Artists. New applicants are encouraged to submit their applications with the understanding that they will be placed on a waiting list.

Artist selection will be by a committee of Rotarian members; their decisions are final. **Due to tree locations, spaces are 12' wide and 18' to 20' long. Choices for booth assignments will be sent out on a first week of April.**

Complete the application, review and sign the agreement and provide the following:

- 1) Artists will not be able to share booth spaces.
- 2) Returning Artist: Send an application fee of \$395; no jury fee required.
- 3) New Artist: Submit two checks:
 - a) A check for the Non-refundable \$25 Jury fee; the check will be deposited upon receipt;
 - b) A check \$395. (Please call or email for Credit Card Payment information)
- 4) Application checks funds will not be deposited until the jury has completed the selection process. If an application is disapproved, the application check will be shredded.
- 5) Checks are payable to "Rotary Club". Returned checks must be replaced with cash or money order plus an additional \$25 fee. Money order must be provided with any application submitted within 10 days of the show.
- 6) Submit 5 Color photos: 1 of booth and 4 photos showing each type of product to be sold (photos will not be Returned. Emailed photos also accepted);
- 7) Copy of your CA Seller Permit, or BOE Permit or LA City Business License.
- 8) If available, staple a Business Card to the Application (to assist with interpreting hand-written info).

I/Helpers will park on the nearby residential streets during the day.
	3. Sunday PM - I/We will <u>first</u> break down my booth, pack my product before retrieving vehicles.
