Rotary International?

Mission— We provide service to others, promote integrity, and advance world understanding, goodwill, and peace through our fellowship of business, professional, and community leaders.

Chartered on February 23, 1905 By Paul Harris and three others in Chicago, IL, Rotary International is an international service organization whose purpose is to bring together business and professional leaders in order to provide humanitarian services, encourage high ethical standards in all vocations, and to advance goodwill and peace around the world. It is a non-political and non-sectarian organization open to all people regardless of race, color, creed, religion, gender or political preference. There are 34,282 member clubs worldwide and 1.2 million individuals, known as Rotarians, have joined.

At the 1917 convention, outgoing Rotary President and member of the Cleveland Rotary Club, Arch Klumph proposed setting up an endowment “for the purpose of doing good in the world.” That one idea, and an initial contribution of \$26.50, set in motion a powerful force that has transformed millions of lives around the globe.

District 6630

Rotary International District 6630 includes over 50 clubs throughout Northeastern Ohio. The district runs east from the Lorain County Line to the western Ohio State line and south to about Route 30. We are one of five districts in Ohio.

Westlake-Bay Village Rotary Club is part of a five club "cluster" that includes North Ridgeville, Fairview Park, Rocky River/Lakewood Sunrise and Rocky River/Lakewood Noon time.

Westlake-Bay Village Rotary Club

Chartered in 1969

The Club was founded and chartered in 1969 by Charles A. Husak, Sr. and Layton K. Washburn as the Westlake Rotary Club and membership was opened to men who resided or worked in Westlake. Eight years later, in 1976, the club re-chartered as the Westlake/Bay Village Rotary Club. In 1988 membership was extended to women.

Membership is drawn primarily from the Westlake/Bay Village area and the Club welcomes all professional and business people in the area, regardless of religion, race or gender.

Meetings: Our Club meets each Wednesday morning 7:30 am—8:30 am. Meetings consist of club updates, a speaker and happy dollar

Dues: Dues of \$250 per person are paid annually in July. Our Club pays your international dues, district, dues, magazine subscription and other fees to the Rotary International and other divisions of Rotary.

Rotary Banners

It is a Rotary tradition for each Club to have its own banner. When a Rotarian visits another club, particularly in another state or country, it is tradition to exchange banners with that club. The Club has had three pennant designs during its existence, necessitated by the changing nature of the area, as well as the Club's name change.

Westlake Bay Village Rotary Banner

In 1976 our banner was designed by Rotarian Walter W. (Bill) Walzer shortly after Bay Village became a part of the Club's jurisdiction.

"The four wheels on our banner illustrate the way in which the Rotary Clubs activities of the neighboring cities of Westlake and Bay Village, each depicted on a Rotary wheel, mesh precisely with our District and Rotary International, represented on the other two wheels."

"The four gear wheels are also symbolic of the far-reaching influence of Rotary International, portraying the four points of the compass to the four corners of the earth. They also represent the four Rotary avenues of Club service: Club Service, Vocational Service, Community Service and International Service, and also reflect the Rotary Four-way Test of the things we think, say and do. The manner in which the ideals of service and fellowship, as performed at the Club level and transferred through the three levels of Rotary organization, are graphically and colorfully illustrated."

Budgets

Westlake Bay Village Rotary Club Operating Budget

All expenses related to the running of our club are paid from our operating budget that runs on a fiscal year of July 1 through June 30. A budget is developed by the board president in concert with the club treasurer and submitted to the Board for approval no later than the June board meeting.

The William Corley Foundation of the Westlake Bay Village Rotary Club

The William Corley Foundation is a private foundation that is separate from the governance of the Westlake Bay Village Rotary Club, however, all expenses related to the club's charitable activities are paid from through the Corley Foundation.

The Corley Foundation has a separate Code of Regulations and different legal obligations than Westlake Bay Village Rotary Club.

The majority of the money within the Corley Foundation has been designated as the Husak-Washburn Endowment Fund of which only interest or dividends from the principal can be used. Corely has another account that accepts unrestricted revenue from our club fundraisers and member donations and are used for charitable contributions.

Duties of Club Positions

All officers and directors are required to attend the monthly Club board meetings the last Tuesday of the month.

THE PRESIDENT leads and motivates the Club, ensuring that Club members feel valuable, inspired and connected with each other. Appoints committee chairs and members. Conducts Club assemblies and develops a safe environment for youth participants.

PRESIDENT ELECT assists the President in his responsibilities.

SECRETARY keeps minutes of meetings, orders supplies, files all reports and keeps attendance records. Reports Club activity monthly to the District Office. Keeps an updated membership roster.

TREASURER keeps the Club's financial records, issues checks, gives advice and counsel on investments, expenditures and budget. Reports to the Board of Directors for approval and action.

ASSISTANT TREASURER assists the Treasurer with duties such as tracking financial records and Club budget.

SGT. At ARMS arrives early to meetings to ensure the meeting is prepped and ready.

CHAIRPERSONS are responsible for their committee's duties and responsibilities, appoint members to their committee to assist in the duties of the committee; provides a monthly report of their activity to be given to the Club Secretary for reporting to the Ohio District Office.

THE MEMBERSHIP attends Club meetings and social and community outreach events. Supports Rotary financially beyond annual dues and maintains membership in good standing.

Reaching Out to the Community and Beyond

- * **Nicaragua Shoebox Project: Benefitting the Children of Chinandega, Nicaragua**
Our Club coordinates the filling of “shoe boxes” with personal care items, school supplies, clothing and small toys to be sent to children living in poverty in Nicaragua. This past year we collected 890 boxes!
- * **Rotary Youth Leadership Awards (RYLA)**
RYLA is an intensive leadership experience organized by Rotary clubs and districts to develop youth leadership skills while having fun and making connections. We typically send two students each from BV and Westlake.
- * **Rotary Speech Contest**
Provides students with an opportunity to compete in a public speaking competition before an audience, thereby fostering excellence in the art of public speaking and developing the confidence and self-esteem of participants. The contest also brings the concepts of the Rotary “Four Way Test” to the attention of students, develops relationships between Rotary and schools and brings valuable exposure in the community.
- * **Westlake-Bay Village Rotary Club Scholarship**
We provide two \$2,500 scholarships; one to a Bay Village student, one to a Westlake student.
- * **Hospice of the Western Reserve: Ames House Quarterly Family Dinners**
Club members serve a catered meal to those in hospice and visiting family, providing them a much needed break and club members an opportunity to connect in an emotional and compassionate way with community.
- * **Annual Golf Outing**
Held in October, this is currently our major club fundraiser and serves as an opportunity to highlight our club and attract new members.
- * **The Project to Eradicate Polio**
Rotary has been working to eradicate polio for more than 30 years. Our goal of ridding the world of this disease is closer than ever.
- * **Other Contributions in many ways to other Community and Global Projects, from service to funding**
