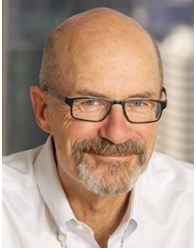


Seattle Rotary Service Foundation – Board of Trustees

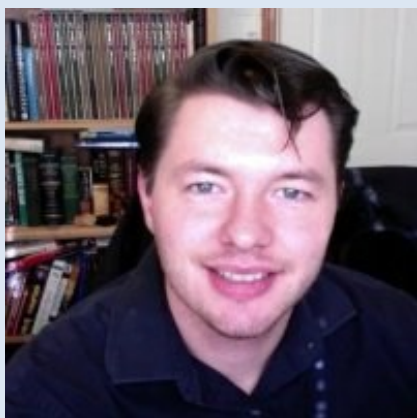
Goodwill for 10 years. If I am fortunate to represent you to further our mission, I will do my best!
