### ROB LOBOSCO

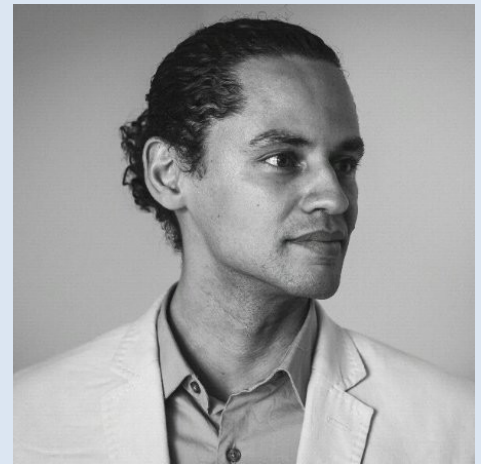

**ROBYN GRAD**

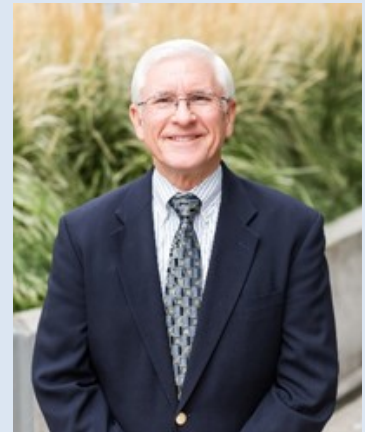
