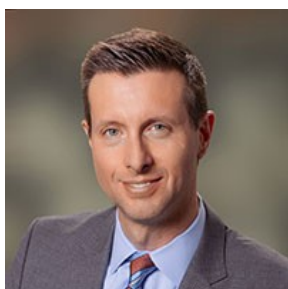


Mary Johnstone

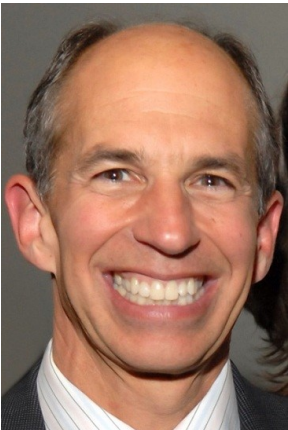
