I agree on behalf of myself and the child to release and hold harmless the Foundation, the Rotary Club of Carpinteria, and their respective affiliates, officers, directors, volunteers, agents, employees and representatives, from all claims and/or liability for any injuries and/or illnesses sustained by the child, or me or any other person, which may directly or indirectly result from the child's participation in music lessons.
