## Membership Levels

### 1. Standard Membership

- Cost: \$350 per quarter
- Includes: RI and District dues, meals at regular club meetings, and \$15/quarter contribution to the Rotary Foundation

### 2. Corporate Membership

- Cost: \$350 per quarter for 1<sup>st</sup> member and \$100 each per quarter for 2<sup>nd</sup> and 3<sup>rd</sup> members
- Includes: RI and District dues, meals at regular club meetings, and \$15/quarter contribution to the Rotary Foundation
- No additional lunch billing for 2<sup>nd</sup> and 3<sup>rd</sup> members attending regular club meetings
- Goal: To strengthen the Rotary club's partnership with organizations

### 3. Premium Membership

- Cost: \$600 per quarter
- Includes: RI and District dues, meals at regular club meetings, and \$15/quarter contribution to the Rotary Foundation
- Premium perks:
  - Special recognition badge/pin
  - Ad or recognition on club's website
  - Listing in calendar/newsletter
  - 2 tickets to the *Mardi Gras* event and a 1-page recognition in the program
- Goal: To honor and recognize Rotary club members who wish to contribute more without creating exclusivity

### 4. Legacy Membership

- Cost: \$200 per quarter
- Includes: RI and District dues, meals at regular club meetings, and \$15/quarter contribution to the Rotary Foundation
- Eligibility: Age + Rotary membership years = 85 or more  
Minimum 20 years as a Rotarian
- Goal: To keep long-time members connected while reducing their membership costs

### 5. Emerging Leaders Membership

- Cost: \$150 per quarter
- Includes: RI and District dues, meals at regular club meetings, and \$15/quarter contribution to the Rotary Foundation
- Eligibility: Under 40 – for younger professionals or those with financial constraints
- Duration: 12 months, then Rotary Board review for consideration of upgrade
- Goal: To engage future leaders and encourage involvement
