

PHILANTHROPIST OF THE YEAR AWARD



The Rotary Foundation and the California Rotary Districts have been selected as the 2023 Bernard Osher Philanthropist of the Year by the Network of California Community College Foundations. The award was given in a special video presentation during our luncheon meeting April 3, 2024, with members of Rotary Ventura East in attendance.

Speakers at the presentation included Rotary International Director Dan Himelspach and Rotary 5240 District Governor Marta Golding Brown. Community college students and graduates gave inspiring statements about how they have benefitted.

California community colleges serve 1.8 million students, fifty percent of whom experience food insecurity. Three years out from earning an AA degree, the average graduate earns \$11,000 more than high school graduates. Rotary has donated \$6.2 million to California community colleges.



COFFEE GROWING IN VENTURA



Dave Armstrong, CEO of Hobson Family Farms, gave a presentation at our meeting April 3, 2024. As economic factors have made lemon production less profitable, Hobson replaced lemon orchards with coffee growing and processing under the FRINJ Coffee label. The climate in their Aliso Canyon farm is ideal to grow the four award-winning coffee varieties they are using. With 18,000 coffee trees, it is the largest coffee farm in the mainland U.S. Hobson also produces the Flying H single-estate wines, vinegars, chili pastes, botanicals, tea, and beef.

UPCOMING EVENTS

April 10 lunch meeting: District Attorney Erik Nasarenko and Lead Human Trafficking Prosecutor Rikole Kelly.



Erik Nasarenko was elected Ventura County District Attorney on June 7, 2022, after his unanimous appointment by the Board of Supervisors the prior year. As the County's top prosecutor overseeing more than 100 deputy district attorneys and 58 sworn investigators, Erik has initiated specialized efforts to prosecute fentanyl-based crimes, analyze untested rape kits, dismantle theft rings, and expand services to crime victims.

Prior to becoming District Attorney, Erik served and protected Ventura County as a senior prosecutor, where he secured jury trial convictions

against defendants for child molestation, rape, kidnapping and murder. In 2016, he was named Prosecutor of the Year by the Ventura County District Attorney for his trial advocacy on behalf of children, women, and sexual assault survivors.

Erik previously served as Mayor of Ventura and as a city councilmember. The son of Ukrainian immigrants, Erik grew up in the San Fernando Valley and is a graduate of the University of California, Irvine, where he studied American History and played intercollegiate soccer. He attended Loyola Law School at night while working during the day as a school district administrator. Married with two teenage children, Erik is a proud board member of the National Alliance for Mental Illness, also known as NAMI, California chapter.



Rikole Kelly – Deputy District Attorney. With over nine years of prosecutorial experience, Rikole Kelly has been a steadfast advocate for vulnerable victims. During her tenure at the San Diego County District Attorney's Office, she handled cases spanning misdemeanors to murders, specializing in arson and explosives. In 2021, Rikole transitioned to the Ventura County District Attorney's Office, where she is dedicated to the investigation and prosecution of human trafficking and sexual exploitation offenses. Collaborating closely with the Ventura County Human

Trafficking Task Force and the FBI Child Exploitation and Human Trafficking Task Force, she channels her expertise into raising awareness and ensuring accountability for perpetrators involved in these crimes.
