HISTORY

Members of the Rotary Club of Hyde Park established this worthy charitable trust in 1997. The purpose was to create an invested fund, and use the earnings from that fund to help bring permanent change in direction to the lives of disadvantaged and marginalised youth who were deemed to be at risk.

The Rotary Club of Hyde Park donated the initial funds to establish the Trust, and continues to promote its growth and activities.

VISION

The stated object of the Trust is:

"To provide disadvantaged or marginalised children under the age of 18 with educational life changing experiences, and/or to assist their spiritual well being."

This is being achieved by looking at applications from both individuals and organisations working with children at risk. The Trust looks for those applications with the potential for maximum effect for the cost involved. We look for individuals who show the most potential for change if they were to participate in events such as leadership or self-awareness camps, or other activities that can achieve a similar result.

MANAGEMENT

The trustee of the Trust is The Rotary Club of Hyde Park Charitable Trust Inc. The only function of this registered association is to act as the trustee. The association appoints a management committee, drawing on a number of people with skills in various areas such as investments, youth affairs, youth activities and administration.

The committee maintains regular contact with people and organisations working with disadvantaged youth, and those offering programs for their benefit. In particular, the committee can draw on the great expertise and wide range of contacts available within the Rotary organisation.

THE FUTURE

The success of the Trust will be measured by the difference it has made in the lives of the successful applicants. The management is not only dedicated to community service and helping those in need, but also focuses on achieving results, and using the funds in the Trust to achieve maximum benefits.

The founders envisage the Trust will continue for generations to come. Much care was taken in setting out goals so the Trust would be timeless and enduring.
