## THE EVENT

The **nothin' but net** is a 3-on-3 basketball tournament in which teams of four players compete against other teams of similar ability in a double elimination format. The tournament is open to all teams including men, women, corporate, church, league, school, scout, and any other group who can organize a team. Proceeds from the **nothin' but net** benefit the Brattleboro Sunrise Rotary Scholarship Fund.

## LOCATION

The **nothin' but net** will take place on Saturday, March 16th, 2019 at the Brattleboro Union High School and Middle School complex on Fairground Road, just off Exit 1, I-91 in Brattleboro, Vermont.

## DIVISIONS

Divisions will be developed at the discretion of the **nothin' but net** Committee based on age and size of players on each team and the number of teams entering the tournament. Expected divisions: Jr. High Boys & Girls (grades 7-8), High School Boys & High School Girls, Adult Division.

## PRIZES

Prizes will be awarded to all division winners. Adult \$100 cash 1st place, \$50 cash 2nd place.

## OFFICIAL **nothin' but net** RULES

1. Each team should field four players on their roster. All games must start with three players, however a lesser number may complete the game. Additions and/or changes of players will not be permitted without written authorization from the **nothin' but net** Organizing Committee.
2. Each team is allowed one 1-minute and one 20-second time-out. Unlimited substitution is permitted.
3. A five minute forfeit time will be strictly enforced.
4. Flagrant fouls or continuous misconduct will result in forfeiture and dismissal from the tournament.
5. Games will be to 20 baskets, win by two points or 30 minutes, including the warm-up period, whichever comes first. Each basket counts one point, except for baskets made from beyond the two point line.
6. The ball will change possession after scored baskets. No make it, take it.

7. Court monitors will be on site to ensure that all games begin on time, interpret rules, keep score, and settle disputes.

8. The ball must be "taken-back" on each change of possession. Beyond 3-point line failure to "take-it-back" will result in loss of possession and point just scored.

9. A coin flip before the start of the game will determine who gets the ball out-of-bounds first.

10. If a player is fouled in the act of shooting and makes a basket, the basket counts and the ball changes possession.

A complete list of rules will be available at the tournament.

## TEAM CHECK IN

All registered teams must check in at 8:30 a.m. at the Brattleboro Union High School gym. Games will start promptly at 9:00 a.m.

## TWO-3 POINT CONTEST

(Men's division and women's division)

In addition to the three-on-three tournament, Sam's Outdoor Outfitters 3-Point Contest will be held at noon, open to all participants and the general public for a \$5.00 entry fee. Prize will be a \$50.00 gift certificate. Limit first 30 entries.

## SPECTATORS WELCOME

Spectators of all ages are welcome throughout the event. A concession area will be open featuring a variety of snacks. Alcoholic beverages are prohibited. No smoking will be permitted anywhere inside the school.
