Corporate Membership Program

Membership options now enable senior leaders and managers of regional corporations to increase the awareness of their firm's social and civic concerns by an affiliation with the Rotary Club of Rutland.

What's The Plan?

This Corporate Connection is established when a senior management leader agrees to join the Club together with no fewer than two managers who will be inducted as Active Members of the Club.

1. The CEO/Pres./Senior Executive will be welcomed by the Rotary Club of Rutland as an *Honorary Member*.

We are professional and business leaders as well and we understand that schedule pressures may prevent a senior leader from active participation. Attendance is voluntary.

No Initiation Fee.

No Annual Dues.

The Firm is encouraged to consider an annual donation of no less than \$200 to the Rotary International Foundation.

2. CEO Nominates Two Managers for Consideration to be Active Members of Rotary Club of Rutland

Two or More Members of Management may be recommended by the CEO for Active Membership.

The approval process and dues will be the same for them as it is for all Rotarians. Reasonably regular attendance is required and active participation at club meetings, service projects and fundraising efforts is expected.

No Initiation Fee.

Annual Dues: \$150.

(Invoiced \$75, Jan and July)

If any of the members of the Corporate Connection are transferred or leave their positions in the region others may be nominated to replace them in the case of the *Honorary Member* or the Active Members.
