The guest speaker of our business meeting on May 15 was a fellow Rotarian from the Club de Beyrouth, a friend of our club who shared with us his passion for Caucasian Rugs. Dr. Aziz Bassoul, an engineer of the Ecole Centrale de Paris, Chief Finance Officer and Director of the C.A.T. Group of companies, took us on a journey of history, geography and artistic splendor of the making of these rugs.

The beautiful and colorful rugs of the Caucasus fall into seven categories based on the region where they were crafted: Kazak, Gendje, Karabakh, Kouba, Chirvan, Moghan and Talich. Originally they were a product of a tradition of nomadic people, and an expression of ethnic and tribal language. Each design held its own symbolism, and the diversity of designs and depth of colors were taught and passed on from one generation to another.



With the rise of the Persian Rug with its own beauty and tradition, the Caucasian Rugs took a back seat for many decades. Nowadays, there is a renewed interest in the art of Caucasian Rugs by dealers and collectors all over the world who think that this form of art holds an equally important place as masterpieces of painting, sculpture and music.

On April 26, 2018 District Governor (D2452) Christina Covotsou Patroclou held the annual district conference in Paphos, Cyprus. The conference was attended by 250 guests from all over the district. PP RI Carl Wilhelm Stenhammer represented President RI Ian Riseley. The general theme was "Rotarians are people of action, who strive to make a difference". It was a meeting where Rotarians celebrated their achievements and strengthened the bonds of friendship among each other.

RCBC was represented by President rabab Safieddine and PP Mounir Jabre who came back after being feted with the awards that RCBC amassed for the year 2017-2018. These were: Membership Development and Rotary Awareness, Club Administration, Community Service and The Rotary Foundation (100% member participation).



The highest honor bestowed upon RCBC was from Rotary International. Mr. Eric Schmelling, Chief Philanthropy Officer of Rotary Foundation in Rotary International singled our club RCBC with the following:

- RCBC is one of 1573 clubs in the world to score in the top three highest in per capita annual giving.
- RCBC is one of only 5034 worldwide to achieve status as in Every Rotarian Every Year Club.
- RCBC is one of 4136 clubs worldwide to become 100% Foundation Giving Club.













These are all great honors knowing that there are 33,000 Rotary Clubs in the world and there is no greater honor than the knowledge that Rotarians DO MAKE A DIFFERENCE!





On May 29, Dr. Bettina Bastian was the guest speaker. Dr. Bastian is a Professor of Management and Entrepreneurship at Olayan Business School of AUB. In her talk provocatively titled "Is business ethics an oxymoron or good business?" Dr. Bastian covered the definition of business ethics, its importance and relevance in the corporate world and the role of culture in shaping and influencing how companies formulate and execute corporate governance.

While maximizing profits remains the main objective of a corporation, Dr. Bastian asserted that it is not a zero sum game and the interests of other stakeholders like shareholders, employees, government and society at large should be taken into account.

Dr. Bastian then went through some well-known and documented cases where the absence of a moral and ethical compass and the failure or non-existence of corporate governance led to catastrophic results for the companies concerned, its employees and the communities where they resided. Enron, Goldman Sachs, Madoff, VW emission scandals and more recently Wells Fargo are a vivid example of the need to install and practice a code of conduct and a value proposition that is inclusive to all stakeholders.



Closer to home, Dr. Bastian addressed the MENA region. Through her research of 102 companies, she noted a glaring lack of proper disclosures and transparency. This limits accesses to capital markets and the interest of investors in investing in such companies.









Dr. Bastian concluded that Business Ethics is not an Oxymoron. It is a risk management tool, but,
