Membership Costs

- *Annual membership dues for the first two members sponsored by a corporation/organization shall total \$600 per year (\$350 for the first sponsored member and \$250 for each additional sponsored member).*
- *The sponsoring corporation/organization shall be responsible to the club for the payment of the annual dues of each member it sponsors and for the initiation fee of the first member it sponsors. The initiation fee is then WAIVED for each additional member sponsored by the sponsoring corporation/organization after the first member so sponsored.*
- *The sponsored members shall be responsible to the club for all other financial and participation obligations of individual active members (such as fees, fines, ROTO obligations, assessments, service projects, attendance and so forth).*
- *If a corporation/organization has sponsored members of the club, then its owners and employees other than the members it sponsors ("Associates") shall also be welcome to attend club meetings and functions as guests, regardless of whether a member sponsored by the corporation/organization is in attendance.*
- *At any time, the corporation/organization may prospectively cancel its sponsorship of an individual, but no refund of dues or other monies shall be made by the club to the sponsoring corporation/organization.*

IMPORTANT INFORMATION FOR PROPOSED MEMBER

1. There is an initiation fee of \$95 due for the FIRST Corporate Member when proposal is submitted to the Board of Directors. The initiation fee is waived for consecutive Corporate Members.
2. Omaha-Millard Rotary Club annual dues are \$350 for the FIRST Corporate Member are due in full on the first day of the Rotary year (July 1.) Dues are pro-rated for members joining after that date. Annual dues are \$250 for each consecutive Corporate Member.
3. The Omaha-Millard Rotary Club raises its primary funds through the sale of ROTO raffle tickets in November-December. By club decree, each member is responsible for the sale or purchase of one book (10) of these \$15 tickets (a total of \$150.) The proceeds are used to fund college scholarships for Millard Public School students. A drawing is held for cash prizes to holders of the winning tickets.
4. Members are expected to maintain 50% attendance at Rotary meetings, including attendance at other Rotary clubs and Rotary-sponsored community service activities.
5. Initiation fee will be refunded if a New Member proposes another new member within the first 90 days of membership. The first new member's initiation fee will be refunded upon receipt of payment of the newly proposed member's initiation fee and dues.
