### **Program/Speaker:**

• Russ Michaletz served as day chair. In keeping with tradition, he disclosed something that he was pretty sure none of us knew about him - - that whenever he goes to someone's house where there is a dog and/or a toddler, both immediately gravitate to him, much to the chagrin of his wife. He has no explanation for this, but says it's always been that way. Hmmmm...

Our speaker today was Mike Tewksbury. The subject of the presentation was the collapse of the 35W bridge in Minneapolis which occurred 10 years ago yesterday. Mike was one of three attorneys who served as an administrator of the Minnesota

funds which had been set aside by the Legislature to compensate the victims of the collapse. Within months after the collapse, the Legislature addressed the need to increase the funds available from the State, and Mike and his colleagues labored for 22 months to ensure that each victim was able to receive a fair level of compensation within the limits established by the State. In all there were 13 deaths and 166 injuries, and all of the victims and their families were represented by attorneys who worked pro bono to assist them through the process. Following the distribution of the State funds, the victims and their attorneys were then able to seek compensation from the construction firm for the bridge, as well as the engineering firm, and thus, along with the funds from the State, were fairly compensated for their losses. Court filing fees were waived on their behalf, and the insurance companies involved even waived their subrogation rights.
