On average, a Rotarian can plan on committing 72 hours per year to Rotary or the equivalent of 1.5 hours per week.

Rotary Clubs pay dues on behalf of its current members in July and January of each year. As of July 2020, Warren Rotary members pay \$165 every six months.

For a new member, there is a one-time \$50 initiation fee plus membership dues that must be paid in order for the induction into Rotary to take place and for that new member to enjoy all the benefits available to our club members.
