



## 34<sup>th</sup> Annual Perrysburg Rotary Auction

On February 3, 2018, the Perrysburg Rotary Club will host its 34th Annual Charity Auction at the Hilton Garden Inn at Levis Commons. Our theme this year is “Rotary Rocks”. We invite you to show your support for this cause by joining us as a sponsor and/or donor for this special event.

Half of our Auction’s proceeds are invested in our corpus with the remainder divided between the grant-making budget and our “Gifts From the Heart” (or Paddle Raise) beneficiary.

Our “Gifts From the Heart” Beneficiary” this year is **Cherry Street Mission’s Life Revitalization Center.** Located at the former Macomber High School in downtown Toledo, the **Cherry Street Mission’s Life Revitalization Center** offers education, vocational training, jobs-skills and placement services to low-income and homeless children, women and men in Northwest Ohio and Southeast Michigan.

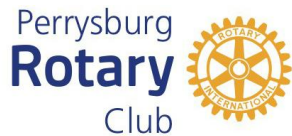
