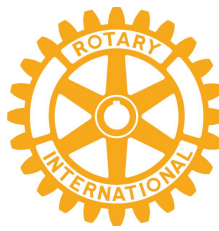

**Quarterly Dues: \$300**

- Attendance can be virtual or in person.
- One company representative will be listed as the business member, however any one representative may attend the weekly meeting in person on the company's behalf. Virtual attendance is open to the business.
- Additional representatives may attend in person at any time for the cost of the lunch, billed to the business. *\*\$300.00 fee will cover Membership Dues, Foundation Dues, Scholarship Dues and Lunch Dues.*

**Virtual Membership:**

**Quarterly Dues: \$100**

- Attendance in weekly meetings will be virtual.
  - Member will be personally responsible for all dues and payments.
  - Member will physically attend one meeting, social or service project each quarter to meet membership requirements.
  - Member is responsible for paying the cost of lunch when attending meetings in person.
  - Member Installation Fee is waived.

DECLARATION OF ROTARIANS  
IN  
BUSINESS AND PROFESSIONS

As a Rotarian engaged in a business or profession, I am expected to:

1. Consider my vocation to be another opportunity to serve;
2. Be faithful to the letter and to the spirit of the ethical codes of my vocation, to the laws of my country, and to the moral standards of my community;
3. Do all in my power to dignify my vocation and to promote the highest ethical standards in my chosen vocation;
4. Be fair to my employer, employee, associates, competitors, customers, the public and all those with whom I have a business or professional relationship;
5. Recognize the honor and respect due to all occupations which are useful to society;
6. Offer my vocational talents: to provide opportunities for young people, to work for the relief of the special needs of others, and to improve the quality of life in my community;
7. Adhere to honesty in my advertising and in all representations to the public concerning my business or profession;
8. Neither seeks from nor grant to a fellow Rotarian a privilege or advantage not normally accorded others in a business or professional relationship.

**Paul Harris**



Rotary started with the vision of one man – Paul Harris. The Chicago attorney formed the Rotary Club of Chicago on 23 February 1905, so professionals with diverse backgrounds could exchange ideas, could form meaningful, lifelong friendships, and give back to their communities.

***Paul Harris Fellow***

The Paul Harris Fellow program recognizes individuals who contribute, or who have contributions made in their name, of \$1,000 to The Rotary Foundation of Rotary International.

The honor was established in 1957 to show appreciation for contributions that support our Annual Fund, PolioPlus, or an approved Foundation grant.
