- Opening Words you've probably noticed that there has been a lot of variety with these (which is great!) – some people write something themselves and some people find something to quote from. It can be a prayer, a poem, something inspirational, the 4-Way Test, thoughts about spring, whatever!

<u>President's Discretionary Fund</u> – One of the line items in our club budget is the "Discretionary Fund." It can be your favorite charity (for example many people designate it for the Food Cupboard or the soup kitchen) or it can be someone down on their luck that you think is worthy of some financial help. All you have to do is either ask Nancy Irving to make out a check to the donee, or reimburse you if you have already donated.

The Anniversary Celebration Continues – This week Bill Daviero educated us about the cultural environment in 1917, the year that The Rotary Foundation began. Popular at that time were Mario Lanza (singing Santa Lucia and O Sole Mio), Mary Pickford, Lillian Gish, the Ziegfeld Follies, and a song about a horse. It seems that a jockey named Little Johnny Jones went to England and raced on a horse called Yankee Doodle. George M Cohan wrote a song about it which of course we all know as Yankee Doodle Dandy. Bill led us in a rousing rendition of it, but unfortunately the mariachi band which he had in the wings last week was not able to come back this week.

P.S. to those who were fact-checking Bill before he even sat down – The Star Spangled Banner was set to music many years after the lyrics were written. But apparently there were several versions of the melody so Woodrow Wilson commissioned some musicians (including John Philip Sousa) to come up with an official arrangement. That official arrangement debuted in ...1917.

Brunswick Landing – Our speaker this week was Steven Levesque, a member of the Brunswick Rotary Club and the Executive Director of MRRA (Midcoast Regional Redevelopment Authority). The MRRA is tasked with turning the former Brunswick Naval Air Station into a thriving business park. They are well on their way and have been able to replace almost 1,250 jobs so far. Since the new jobs are better-paying than the 5,000+ jobs that were lost, they have actually replaced almost 2/3 of the dollars those jobs represented. There are 100 different businesses at Brunswick Landing, 25 of which are new to Maine. Btw, the MRRA does not do

any promotional activities in Maine – only out of state. And they won't allow a Maine business to relocate to the Landing unless they can demonstrate that their current community cannot accommodate their needs. Steve and the MRRA are targeting aerospace, information, composite and energy businesses. Since the property being developed at Brunswick Landing is no longer tax-exempt, the businesses there generate \$2.6 million in property taxes for Brunswick and Topsham each year.
