<u>Scholarships!</u> – Kathy Cotter announced that once again we had a group of outstanding applicants for our high school scholarships. Fourteen students were interviewed and all were awarded \$2,000 scholarships – 8 from CEHS and 6 from SPHS. Thank you to Kathy and Nicole and Mike Geneseo, who helped interview the students.

<u>More About the RI Board</u> – The get well wishes above mention the director from our zone. So for those not familiar with the board/zone structure, here's how it works. The Rotary world is divided into 34 geographic zones. Each zone is paired with another zone and the paired zones are entitled to be represented by one director on the RI board of directors (so 17 zone directors plus the president and president-elect make up the RI Board). The directors serve a 2-year term and alternate between zones. We are in Zone 32, which is made up of most of New England, New Jersey part of New York, and Pennsylvania, Bermuda & parts of Canada. We are paired with Zone 28, which consists of parts of Maine, Michigan and New York and Washington and Alaska as well as part of Canada. (So for instance we are in Zone 32 but Lewiston just up the road from us is in Zone 28.) Drew Kessler is a member of the North Rockland, NY Rotary club and is our current director from Zone 32, with his term ending next month. On July 1, he will be succeeded by a representative from the other zone (28) – a woman named Chris Etienne from Petoskey, Michigan. Our paired zones were represented by last year's RI President Jennifer Jones from the Rotary club of Windsor-Roseland, Ontario. And our own club has been represented on the Board by Dan Mooers and Mike McGovern.

<u>"It Ain't No Fluke"</u> – SpringFest co-chair Jim Britt said that he wondered if last year's successful event was a fluke, but he concluded otherwise. Here's another summary of the event from a little girl at Redbank named Esmeralda who was grooving to the band's music while she took great pains decorating her gnome hat: "This is the happiest moment of my life." So no question that both days were a tremendous success. Jim reported that he and the city had estimated that about 3,000 people attended the event at some point. He prepared a report called "SpringFest Sponsor Recap & Success Stories" which he shared with our sponsors. Jim listed some areas that we could improve upon next year and Rotarians added their own suggestions as well. Congratulations to Jim and Sari for a fabulous job!!!







# Board minutes and financial statements

This describes how to get to the club board minutes and financial statements.

1. You need to know your username and password; these are not public documents.

2. Starting from the home page, click on the "Members Only" menu and then select "History".



3. The left side menu lists Club years, pick the one that you want. This example uses 2023-2024.

History by Year 2023-2024 2022-2023

- 4. This brings you to the history page for the selected year. Generally, there is a lot of information, but unfortunately it is not consistent.
  - a. Older years typically only have newsletters and a few other items.
  - b. More recent years have much more, including photos, presentations, board materials, thank you notes, letters, etc.
  - c. Much depends on availability of materials. Some available material isn't posted yet, volunteers welcome!
- 5. The point of this missive is under "Board Meetings", so click on that item.

- 6. Here's a bit about what the items are under "Board Meetings".
  - a. This material is grouped by board meeting (i.e. month)
  - b. Again, it depends on what was available to Scott
  - c. "Board Minutes" is pretty self-explanatory.

- d. Note for the financials: The board meeting will have the books that closed at the end of the prior month, e.g. The October board meeting lists the books closed Sept 31. So, if you're interested in what happened in September, look at the October meeting.
- e. "External financials" is the finances for the charitable fund. This is an excel spreadsheet. Starting in July 2023 is was taken from QuickBooks. Prior to that it is a copy of the accounting spreadsheet that was used.
- f. "Internal Budget" are the books kept for operational costs. There is often an "Internal Summary" item, this is from the email Kathy sends with the budget file, and captures the highlights.
- g. If a director's report is available to Scott, it is posted.
- h. If any supplementary materials for the meeting are available to Scott, they are posted.
- i. The items under the "Initial" header are from the planning process.
- j. If there was a special board meeting, you may see two headers for a given month, e.g. look at April 2024.
- k. The annual reports have only been done for the past few years so most years don't have them.
