# Executive Director Region 5 Education Service Center

Jim Baxter introduced Dr. Danny Lovett, Executive Director of the Region 5 Education Service Center, to provide an overview of the service center. There are twenty ESCs in Texas, and the centers serve as the service arm of the Texas Education Agency. The various service centers are not regulatory agencies.

The Region 5 center was established in Beaumont in 1967, and serves from High Island to the Louisiana border, up to Jasper, and west to Chambers County. The service centers exist to assist schools with academic achievement needs, to help schools operate more efficiently and economically, and to assist with implementation of legislative initiatives. The goal is to help schools in whatever way the service center can. Region 5 includes 32 independent school districts, 8 charter schools, about 180 campus, and about 90,000 students. The service center works with nearly every possible constituent group associated with a school or ISD: Boards, administrators, faculty and staff members, students, and external constituents.

Since 2005, the Region 5 service center has increased it's number of annual workshops from 700 to 1,249 serving approximately 17,000 people in 2011-2012. Approximately 6 million contact hours are provided by all twenty service centers in Texas each year. In 2011-2012, approximate total savings for Texas schools was over \$67,000,000. Dr. Lovett shared additional financial information about school savings as a result of interaction with the state's service centers, including over \$800,000,000 statewide education savings in 2011-2012. The total state funding for the services centers is \$12.5 million per year, which is then divided among the twenty service centers.

The Region 5 center's goals are to hire the best possible service staff, deliver quality services to area schools, promote a team-based and service-based environment, and provide facilities and equipment to meet client needs. The Region 5 center recently combined its Beaumont and Silsbee offices and moved to Edison Plaza in Beaumont. The new offices provide 21st century training facilities, which the center can make available for area businesses and organizations to use. The center sees itself as a full partner with area ISDs, and in some cases even runs the business office (payroll, etc.) for many of the smaller area schools that are unable to afford a business manager. The center also offers teacher and principal certification programs. The center also assists ISDs with acquiring needed technologies, and coordinates emergency services planning and emergency technology services for area ISDs. The service center has 90 full time staff members with about 20 more part time employees. Nearly 70% of Region 5 students are socioeconomically disadvantaged.
