

PROGRAM REVIEW October 2, 2013

"Update on the 83rd Legislative Session"

Our speaker today was Senator Tommy Williams. Senator Williams was introduced by Vice President Paul Szuch.

Senator Williams talked at length about our last Legislative session. This covered a wide-range of topics, from gas and taxes, to water rights.

Senator Tommy Williams represents Texas' District 4 in the state Senate and serves on the education, finance, and industrial relations and trade committees.

Senator Williams told Rotarians that Texas has developed a national recognition for new job-growth, saying "People want to come to Texas to start their businesses."

The Senator also stated that Texas has two big assets:

- 1) legislators worked on the sustainability of the 'Rainy Day Fund;' $\,$
- 2) Texas had about \$6 billion in no-strings-attached federal stimulus money. This \$6 billion helped to offset the majority of the shortfall from the LAST budget session.

With job-growth comes the growth of our student population. Regarding education, when adjusted for size and ethnic diversity, Texas is #1 in educational achievement in the U.S. Every year, there is an influx of about 20,000 new students to school districts across the state, similar to adding a new student census of one new Beaumont Independent School System every YEAR, which is quite a challenge.

Senator Williams stated that the new federal health care law would likely require a state tax increase because it would require the state to earn an additional \$24 billion to pay for the plan. Senator Williams also mentioned our highways, and the failure of Texas Windstorm which made no progress last session. Currently, highways are funded via the gas tax. However, with more fuel-efficient cars, the state earns less per lane mile, thus reducing income from the gas tax. A new way to fund highways must be developed.
