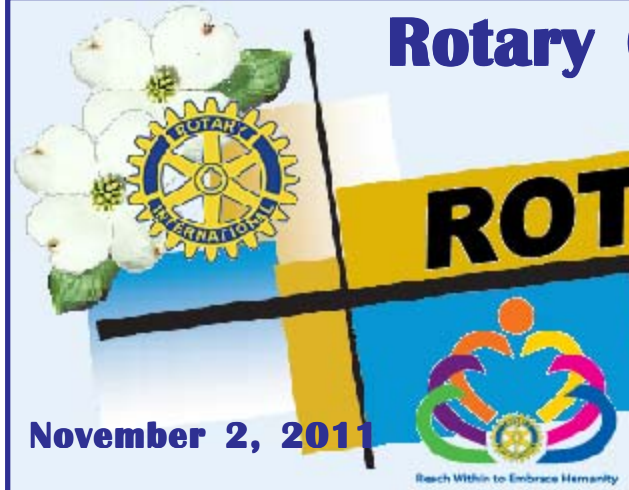

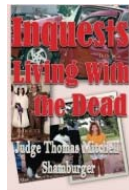

What Happened Last Week

Our speaker, Carroll Sigman brought a fresh and deep insight into our tourism industry here in Palestine. And, as he pointed out, it is a huge industry. Money spent here by visitors circulates through our local economy by a factor of seven, and is a major source of income and employment for our town. Tourism is, obviously, a major source of income of the hotel industry, for which he is a spokesperson. Though the hotel-motel tax collected here by that industry does not go directly into their coffers, the hotel operators are keenly aware (and interested) in just how that money is spent to further tourism here. For it is tourism that has a direct impact on their bottom line-as well as the bottom line of many of our local businesses. Carroll pointed out how many of our visitors are former residents, coming back home for one reason or another-just to visit, a reunion, a funeral, a special local event like the Dogwood Trails, etc. But they do come back. He also told of a meeting of the Hotel owners group, that he organized, in which the group spoke about the special qualities of Palestine, Most important, is our people and our life style, at least as perceived by our visitors, and as projected by us. But it is clearly intrinsic to our town, and something that we all love and probably take for granted. While that makes us all happy, we should be aware of it, and not do anything to dispel that notion. Mr. Sigman gave us much to consider about our town and ourselves, and reminds us that we are all players in the promotion of our area-whether we mean to be or not. Members of our club are involved in nearly all aspects of tourism here in Palestine.
