What Happened Last Week

- Dr. Randal Horn was introduced by Alan George. Dr. Horn described his path from many years of study and practice of Psychology into his present profession as a Medical Doctor. He stated that his work as a psychologist was invaluable to his present medical practice of internal medicine, which he described as a patient-centered approach. Dr. Horn presented a well-structured look at what could be called "Every person's general guide to health and medicine," emphasizing how our individual behavior plays a defining role in our health and in our relations with the medical profession. He spoke of seven behavioral risks that have serious personal and national health consequences and represent the primary source of most of illnesses that he sees, including: Use of Tobacco; Alcohol over-consumption; Dietary habits; Drug use, Risky Sexual conduct; and failure to heed medical advice. His discussion of our dietary habits caused most of us to balefully inspect our plates.
