Steve Spencer registered his thanks to the club members who helped put the dictionaries together for distribution. Great project.

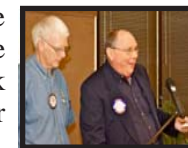


A wonderful time was had at the Wine Tasting event at Granny Muffins.
