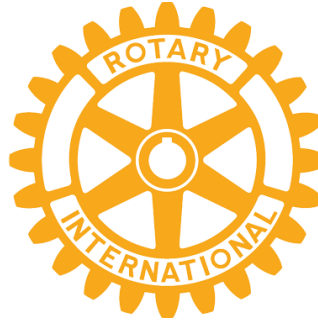


# Rotary



Rotarians who reside in Mississippi may obtain a special Rotary International automobile license plate to replace their regular license plate, provided at least 200 applications with payment of \$31 are received by the Mississippi State Tax Commission. Production of the tags begins only after the 200 minimum has been reached.

Applicants will be notified by Rotary District 6820 when the tags may be picked up at their respective county tax collectors' offices. Each tax collector's office will have a list provided by the Tax Commission of those who have already paid their fees and are entitled to one of the first 200 tags.

Applicants are urged to pick up their license tags as soon as they are notified the tags are at the tax collectors' offices. The tags **MUST** be picked up within sixty days.

**PLEASE NOTE:**

200 TAGS MUST BE PRESOLD BEFORE THE MISSISSIPPI STATE TAX COMMISSION WILL BEGIN PRODUCTION ON A PARTICULAR DISTINCTIVE TAG INCLUDED IN SENATE BILL 2449. WHEN THE TAX COMMISSION RECEIVES THE 200 APPLICATIONS, WITH THE APPROPRIATE FEES, AND A DESIGN PROVIDED BY THE ORGANIZATION AND APPROVED BY THE TAX COMMISSION, THE TAG CAN BE PUT INTO PRODUCTION. THE APPLICANT WILL BE NOTIFIED BY THE ORGANIZATION RESPONSIBLE FOR THIS PARTICULAR TAG WHEN HIS TAG CAN BE PICKED UP AT THE OFFICE OF THE TAX COLLECTOR IN HIS COUNTY OF RESIDENCE. THE TAX COLLECTOR'S OFFICES WILL HAVE A LIST PROVIDED BY THE TAX COMMISSION OF PEOPLE WHO HAVE ALREADY PAID THEIR FEES AND ARE ENTITLED TO ONE OF THE FIRST 200 TAGS.

**THE APPLICANT SHOULD PICK UP HIS TAG AS SOON AS HE IS NOTIFIED THAT THE TAG IS AVAILABLE AT THE TAX COLLECTOR'S OFFICE. THERE SHALL BE SIXTY (60) DAYS ALLOWED FROM THE TIME THE TAXPAYER IS NOTIFIED BY THE ORGANIZATION FOR THE TAXPAYER TO PICK UP THIS LICENSE PLATE, HOWEVER, IF THE APPLICANT CHOOSES TO WAIT TO PICK UP HIS TAG, THE SPECIAL TAG FEE SHALL BE PAID AGAIN AT THE TIME THE SPECIAL TAG IS PICKED UP TO BE REGISTERED TO THE APPLICANT'S VEHICLE.**
