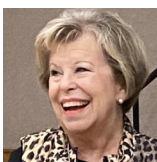

As our club's Foundation Chair, I want to thank each of you for your efforts to support The Rotary International Foundation and its work around the world and at home. Half of the money we donate each year comes back to us in three years to fund our grants and half is used to fund International Grants for our club and others. Over our 100 years, our club has donated \$942,378 benefitting our club and international grants around the world. This year we are requesting funds for our Centennial including the new park and Rotary sculpture in downtown.

RI suggests each member contribute \$100 annually to the RI Foundation. Our club does this is through birthday contributions. Members donate on their birthday in the amount of their age or a little more with a check to "[Rotary Foundation](#)." Rotary tracks each individual's donations. Once \$1,000 accumulates you receive a Paul Harris Fellow (PHF). Our club currently has 84 PHF members! If you'd like to become a PHF or add to the ones you have, notify me to check your records to see how close you are to your next PHF. Currently if you are less than \$500 from your next PHF, the club will match half of the amount you need to complete your PHF! Don't miss out on this great opportunity. RECOGNIZING THE PAST

TO INSPIRE THE FUTURE

IN OBSERVANCE OF VETERANS DAY

During the time period of World War II our Club had its challenges as did any other organization in the U.S. at that time. Here are some excerpts of members writing about the war.

From D.S. "Spurge" Hood, President from 1942-1943: *"World War Two had truly become global. It was unlike any war that had been fought since history began. Our country was facing its greatest crisis. By January 1943 Texas had more than 300,000 men in uniform. Those were the days when the one thought uppermost in everyone's mind was 'Winning the War.' And what a war!! It was a war of machines and mass production.*

In 1941 an aviation plant had been built at Grand Prairie at the unheard of cost of \$7,000,000 and was employing 12,000 workers. By 1943 this plant had been enlarged to \$35,000,000 and was employing 50,000 workers. Instances like this were taking place all over the country.

During my administration, naturally the question uppermost in the minds of this club and every other similar club was Win the War, Buy Bonds!! Consequently our programs for the year emphasized these efforts. Suffice to say, your club did its part and then some!"

From Happy King, President 1943-1944: *"I do not remember any members that may have died or dropped out of Rotary for other reasons that year. However, I recall that Barney Barnes and Dan Kiber were away on leaves of absence to serve as officers in the Army. I was a general foreman in charge of engine assembly at North American Aviation for that year in addition to being an automobile dealer. At approximately the middle of my term as president, I had to call on my good friend and vice president, Joe Bailey, to preside the remainder of my term in order that I might work 7 days a week in the war effort.*

knowledge of the law, conservative judicial philosophy, strict attention to ethics and hard work, and tried and true efforts promoting Texas values in the ballot box made her well-qualified for this important court.

The court has a \$3.5 million dollar budget. Judge Allen, your probate court judge in Tarrant County, Court No. 2, is responsible for overseeing the probate process. This includes handling all matters related to the estate of a deceased person, such as distributing assets and resolving any debts or disputes. The Probate Court judge also has the authority to appoint guardians and conservators, as well as oversee adoptions.

In addition to these duties, Judge Allen also presides over hearings and trials related to probate matters. This includes determining whether a will is valid, appointing an executor or administrator for the estate, and settling any disputes that may arise during the probate process. Judge Allen also has the authority to order the sale of property in order to pay debts or distribute assets and to issue other orders as necessary to protect the interests of all parties involved in the probate process.

Due to the strife of war, our club did not accomplish anything outstanding. We probably were fortunate to keep intact. Many service clubs had to disband."

In years past we were fortunate, honored and privileged to know and hear first hand stories of Rotarians who were members of our Club. Please take a moment to remember them and in some cases thank their families. Unfortunately no records were kept of members served or lost in service but the ones I remember are Fred Bondurant (Barry's father), Rusty Di Sciuillo and Emory Estes. Although not a Rotarian, Marty Bondurant, Fred's wife and Barry's mother, served in the Army Nursing Corps and attended surgery for 72 hours straight at the Battle of the Bulge.
