Rotary was founded in 1905 by Paul Harris in Chicago, Illinois. It is an organization of business/professional men and women, united worldwide, who encourage high ethical standards in all vocations, provide humanitarian service help to promote goodwill and peace throughout the world. It has grown to include over 20,000 clubs with a membership in excess of one million Rotarians in 155 countries.

The Rotary mottos are "*SERVICE ABOVE SELF*" and "*HE PROFITS MOST WHO SERVES BEST*".

Rotarians must adhere to the following minimum attendance requirements:

1. Must have at least 30% of his/her attendance during each half year at his home club
2. Must attend a weekly Rotary meeting (home club or makeup) at least 60% of the time during each half year
3. Must attend a weekly Rotary meeting (home club or makeup) a minimum of once every four weeks.

HWRC Membership Financial Requirements

Rotary's fiscal year starts on July 1 each year.

HWRC new / initial membership expenses include:

- \$60 Initial membership fee
- \$250 Annual due
- Occasionally, only in-person meetings will have meal charges if held at the restaurant.

Each following July 1 would have:

\$250 Annual due

Additional optional charitable contributions to consider during the Rotary fiscal year:

- \$100 Paul Harris Sustaining Membership (a Rotary International fund)
- \$100 HWRC fundraiser (supporting our club's charities)

Complete the application and return with a check for \$60.00 to the club member proposing you for membership. The remaining initial fees will be collected after the approval process is completed. The Board of Directors meets monthly to review all new member applications for approval.
