

Terms and Conditions

1. This Ultimate Car Raffle (2026 BMW X3 3-Year Lease) is open to only legal U.S. residents aged 18 or older.
2. A maximum of 600 raffle entries will be sold. The odds of winning depend on the total number of entries sold.
3. Raffle entries will be sold physically and electronically. Completed entries may be purchased in the following manners:
 - a. Online orders must be received by **December 12, 2025**. Click [here](#) to enter payment¹.
 - b. At Event: last chance to buy tickets at the registration desk.
 - c. From a Space Center Rotarian via Cash or Check.
 - d. By Check via Mail entries must be received by **December 8, 2025**.

4. Official raffle entries must be legibly completed in their entirety with a name, email address, and telephone number in order to enter the drawing. All entries (potential award winners) must reside in the State of Texas. Only entries that meet these requirements will be eligible for the drawing. No facsimiles are permitted.
5. The Winner will be determined in a random drawing to be held at BMW of Clear Lake on December 14, 2025.
6. The Winner will be notified by telephone NLT December 15, 2022.
7. To qualify, the Winner must present a valid driver's license, proof of vehicle insurance, and pass a credit (approval) check by BMW of Clear Lake to receive the prize. The Rotary Club of Space Center and BMW of Clear Lake reserve the right to determine sufficiency of identification. **Annual Mileage Allowed: 10,000. Any additional miles will incur charges by the dealer.**
